

ORDINANCE NO. 2015-07

AN ORDINANCE AMENDING THE "CITY OF SALLISAW SPECIAL SALES TAX ORDINANCE OF 1978", THE SAME BEING ORDINANCE NO. 78-17, PROVIDING THAT THE ONE-HALF PERCENT (½%) HOSPITAL SALES TAX MAY BE USED TO PAY FOR OPERATION AND MAINTENANCE OF THE SEQUOYAH COUNTY-CITY OF SALLISAW HOSPITAL AUTHORITY IN ADDITION TO THE OTHER PURPOSES SET FORTH IN SAID ORDINANCE 78-17; PROVIDING FOR THE PURPOSE THEREOF; PROVIDING THE EFFECTIVE DATE; PROVIDING THAT PROVISIONS ARE CUMULATIVE; AND PROVIDING FOR SEVERABILITY

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF SALLISAW, OKLAHOMA:

SECTION 1. The "City of Sallisaw Special Sales Tax Ordinance of 1978", the same being Ordinance No. 78-17, hereby is amended by changing paragraph (a) of Section 4 of Ordinance No. 78-17 adopted September 5, 1978, to read as follows:

- "(a) 50% of the revenues generated by such additional tax shall be paid as received to, upon order of the Sequoyah County-City of Sallisaw Hospital Authority, to be used for hospital and health care purposes, including, but not limited to, the payment of debt service on indebtedness incurred by said Hospital Authority; the costs of planning and constructing, renovating, expanding and improving the Hospital, including the costs of feasibility studies, land acquisition and extending utilities thereto; the costs of capital expenditures made to improve the Hospital including the purchase of equipment and furnishings; the making of any payments or transfers required under any bond indenture or other debt instrument securing any indebtedness incurred by said Authority for Hospital purposes; and for operation and maintenance expenses of the Hospital."

SECTION 2. This Ordinance shall become and be effective immediately after its approval by a majority of the qualified electors of the City of Sallisaw, Oklahoma, voting on the proposition and approving the same in the manner

prescribed by law.

SECTION 3. The provisions hereof shall be cumulative and in addition to any and all other taxing provisions of City Ordinances.

SECTION 4. The provisions of this Ordinance are severable, and if any part or provision hereof shall be adjudged invalid by any court of competent jurisdiction, such adjudication shall not affect or impair any of the remaining parts or provisions hereof.
