

**AN ORDINANCE OF THE MAYOR AND BOARD OF ALDERMEN OF THE  
CITY OF CLINTON, MISSISSIPPI, AMENDING THE EXISTING  
ORDINANCES OF THE CITY OF CLINTON AS TO THE PROHIBITION OF  
UNNECESSARY NOISE BY ADDING AN ADDITIONAL SECTION TO  
SPECIFIC UNLAWFUL NOISES AND FOR RELATED PURPOSES**

WHEREAS, on May 20, 2014, a public hearing was held for the purposes of discussing excessive noise as a result of early morning commercial trash removal;

WHEREAS, at said public hearing held on May 20, 2014, a number of citizens expressed concern about excessive noise related to early morning commercial trash removal;

NOW THEREFORE;

BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF CLINTON, MISSISSIPPI, as follows:

Section 3 of the Ordinance Prohibiting Unnecessary Noise

is amended by adding: (o) It shall be a rebuttable presumption that the removal of trash from commercial dumpsters or any other trash/debris removal operations affecting any residentially zoned area of the city between the hours of 10:00 pm and 6:30 am constitutes a violation of this Ordinance.

This Ordinance shall take effect and be in force from and after thirty days from passage.




