# AN ORDINANCE OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SANTA CLARA AMENDING SECTIONS B12-35 AND B12-34 OF ARTICLE 2 OF CHAPTER II OF DIVISION B12 OF THE COUNTY OF SANTA CLARA ORDINANCE CODE RELATING TO THIRTY MILES-PER-HOUR AND TWENTY-FIVE MILES-PER-HOUR SPEED ZONES

### Summary

This Ordinance eliminates the existing 30 miles-per-hour speed limit on Sierra Road between Piedmont Road and Skyview Drive and replaces it with a 25 miles-per-hour speed limit on Sierra Road between 0.15 miles southwest of Skyview Drive to 0.75 miles north of Skyview Drive.

## THE BOARD OF SUPERVISORS OF THE COUNTY OF SANTA CLARA ORDAINS AS FOLLOWS:

SECTION 1. Section B12-35 of Article 2 of Chapter II of Division B12 of the Ordinance Code of the County of Santa Clara is hereby amended by deleting the following described portion of the identified public highway from the list of highways having a thirty (30) miles-per-hour speed zone.

SECTION 2. Section B12-34 of Article 2 of Chapter II of Division B12 of the Ordinance Code of the County of Santa Clara is hereby amended by adding the following described portion of the identified public highway to the list of highways having a twenty-five (25) miles-per-hour speed zone.
