**AN ORDINANCE OF THE BOARD OF SUPERVISORS
OF THE COUNTY OF SANTA CLARA
AMENDING SECTION A34-24 OF CHAPTER III OF DIVISION A34 OF THE
COUNTY OF SANTA CLARA ORDINANCE CODE RELATING TO REVISING
FEES OF THE REGISTRAR OF VOTERS**

SUMMARY

This ordinance amends Section A34-24 of the Ordinance Code of the County of Santa Clara to revise fees and charges collected by the Registrar of Voters.

**THE BOARD OF SUPERVISORS OF THE COUNTY OF SANTA CLARA
ORDAINS AS FOLLOWS:**

Section 1: Section A34-24 of Chapter III of Division A34 of the Ordinance Code of the County of Santa Clara relating to the collection of fees by the Registrar of Voters, is hereby amended to read as follows:

Sec. A34-24. Authorization to charge fees.

The Registrar is authorized to charge and collect fees for various costs and services as set out below.

Base Fees for Primary and General Elections to Cities, Schools, and Special Districts	\$2.87 per registered voter for first item on ballot and \$0.82 for each additional item with the same registration on the ballot, plus costs of legal publications and ballot printing in the mandated languages
Special Elections (All Elections Other than Primary and General)	Actual costs of labor, services, supplies, and election materials in the mandated languages computed after each election


