AN ORDINANCE OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SANTA CLARA AMENDING SECTIONS B12-37 AND B12-38 OF ARTICLE II, CHAPTER II OF DIVISION B12 OF THE SANTA CLARA COUNTY ORDINANCE CODE RELATING TO SPEED LIMITS ON ALMADEN AND CAPITOL EXPRESSWAYS

Summary

This ordinance amends Sections B12-37 and B12-38 of Article II, Chapter II of Division B12 regarding speed limits on Almaden and Capitol Expressways.

THE BOARD OF SUPERVISORS OF THE COUNTY OF SANTA CLARA ORDAINS AS FOLLOWS:

<u>SECTION 1:</u> Section B12-37 of the Santa Clara County Ordinance Code is amended to read as follows (with additions identified in <u>double underline</u> and deletions identified in <u>strikethrough</u>):

The following described portions of the hereinafter mentioned public highways in the County are hereby designated as 45 mile-per-hour speed zones and no person shall drive a vehicle on or along the highways located within the hereinafter described 45 mile-per-hour speed zones at a speed greater than 45 miles per hour.
