RESOLUTION 2023-15268

A RESOLUTION FOR THE PURPOSE OF AMENDING APPENDIX "A", FEES AND CHARGES SCHEDULE OF THE CODE OF ORDINANCES TO ADD A FEE FOR RESTRICTED CHARTERS TO DROP-OFF AND PICK-UP PASSENGERS AT THE NAPLES CITY DOCK FOR ONLY THOSE RESTRICTED CHARTERS APPROVED FOR LANDSIDE USE AT THE NAPLES CITY DOCK BY THE PARKS, RECREATION, AND FACILITIES DIRECTOR; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, City staff recommends that the Waterways (City Dock) Fees be adjusted in Section 28-32(12) of Appendix "A", Fees and Charges Schedule of the Code of Ordinances to reflect the additional fee for Restricted Charter drop-off and pick-up of passengers; and

WHEREAS, Restricted Charters must have approval to use the Naples City Dock by the Parks, Recreation, and Facilities Director and the passengers must provide proof they used public/private transportation; and

WHEREAS, City staff recommends that rates be evaluated bi-annually;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NAPLES, FLORIDA:

Section 1. That the above "Whereas" clauses are ratified, confirmed, and incorporated by reference as if set forth herein as the City Council's legislative findings.


Section 2. That Section 42-83, Waterway (City Dock), of Appendix "A", Fees and Charges Schedule, of the Code of Ordinances is hereby amended to add the following fees:
