ORDINANCE 12-13206

AN ORDINANCE RELATING TO THE PUBLIC ART ADVISORY COMMITTEE; AMENDING SUBSECTION 2-582 (a) (1), (2), (3) AND (4) OF THE CODE OF ORDINANCES, CITY OF NAPLES, TO AMEND THE COMPOSITION OF THE PUBLIC ART ADVISORY COMMITTEE (PAAC); PROVIDING A SEVERABILITY CLAUSE, A REPEALER PROVISION AND AN EFFECTIVE DATE.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NAPLES, FLORIDA:

Section 1. That Subsection 2-582 (a) (1), (2), (3) and (4) of the Code of Ordinances, City of Naples, is hereby amended to read as follows (with underlining indicating additions and ~~strikethrough~~ indicating deletions):

Sec. 2-582. Established, composition, term of office; quorum; officers; oath; meetings and minutes.

(a) The public art advisory committee (PAAC) shall be composed of seven members. Each member shall be appointed for a term of four years and no member shall serve more than two consecutive terms. All appointments require a majority vote of the city council. Whenever a vacancy occurs, a new member shall be appointed to complete the unexpired term of the former member. Any member who consistently fails to attend meetings without good cause shown or without the prior approval of the chairman of the committee may be removed by action of the city council, and the vacancy shall be filled as herein described. Members representing the von Liebig Art Center and United Arts Council shall be nominated by their respective organizations but shall serve out the complete terms described above. The committee shall consist of seven members as follows:

- ~~(1) One member of the city council as appointed by city council serving ex-officio.~~
- (21) Four Five members being private citizens, residents of the city, with knowledge of and appreciation for the visual arts. Citizen representatives may not operate, own, or be employed by any art dealer, art gallery, artist's representative, or other entity which derives income from the sale or display of artwork.
- (32) One member representing the von Liebig Art Center;
- (43) One member representing the United Arts Council,

Section 2. If any word, phrase, clause, subsection or section of this ordinance is for any reason held unconstitutional or invalid, the invalidity thereof shall not affect the validity of any remaining portions of this ordinance.

Section 3. That all sections or parts of sections of the Code of Ordinances, City of Naples, all ordinances or parts of ordinances, and all resolutions or parts of resolutions in conflict herewith, be and the same are hereby repealed to the extent of such conflict.

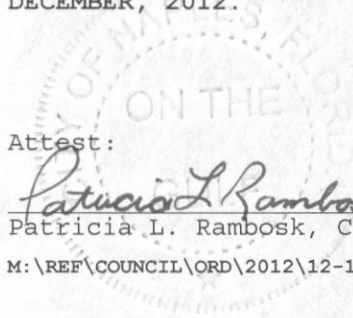
