

RESOLUTION 2019-14343

A RESOLUTION RELATING TO WATER AND SEWER RATES, STORMWATER MANAGEMENT UTILITY FEES AND SOLID WASTE COLLECTION AND DISPOSAL RATES; AMENDING SECTION 30-9, MONTHLY RATES; AMENDING SECTION 30-336, STORMWATER MANAGEMENT UTILITY FEES; AND AMENDING SECTION 32-71, COLLECTION AND DISPOSAL OF REFUSE AND RECYCLABLES, OF APPENDIX "A", FEES AND CHARGES SCHEDULE OF THE CODE OF ORDINANCES, CITY OF NAPLES, TO REFLECT ANNUAL RATE ADJUSTMENTS BASED UPON THE UNITED STATES CONSUMER PRICE INDEX; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Section 30-9(5) of the Code of Ordinances provides that water and sewer rates must be adjusted every October 1 by the current percentage increase of the United States Consumer Price Index; and

WHEREAS, Section 30-343 of the Code of Ordinances provides that stormwater utility rates must be adjusted every October 1 by the current percentage increase of the United States Consumer Price Index; and

WHEREAS, Section 32-71(c) of the Code of Ordinances provides that solid waste rates must be adjusted every October 1 by the current percentage increase of the United States Consumer Price Index; and

WHEREAS, the United States Consumer Price Index increased by 1.8 percent based on the Annual CPI-U; and

WHEREAS, Collier County has notified the City that the solid waste disposal Tipping Fees will be increasing 2.0 percent for FY 2019-20;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NAPLES, FLORIDA:

Section 1. That Section 30-9, Monthly rates, of Appendix "A", Fees and Charges Schedule, is hereby amended to read as follows (with underlining indicating additions and ~~strikethrough~~ indicating deletions):

Section 30-9. *Monthly Rates.*

(a) *Monthly Base Rates.*

(1) *Water Base Rates.*

(a) Single-family residential, commercial, and potable irrigation meter customers must ~~shall~~ pay a monthly water base rate as determined by the size of the installed water meter as follows:

- (b) Multifamily residential customers must ~~shall~~ pay a monthly water base rate of ~~\$5.81~~ \$5.92 for each dwelling unit.

(2) *Sewer Base Rates.*

- (a) Single-family residential customers must ~~shall~~ pay a monthly sewer base rate of ~~\$20.76~~ \$21.13 based on one equivalent residential unit.
- (b) Multifamily residential customers must ~~shall~~ pay a monthly sewer base rate of ~~\$16.19~~ \$16.48 for each dwelling unit.
- (c) Commercial customers must ~~shall~~ pay a monthly sewer base rate based on the equivalent residential unit as determined by the size of the installed water meter as follows:

(3) *Reclaimed Water Base Rates.*

- (a) General customers connected to the reclaimed water system must ~~shall~~ pay a reclaimed water base rate based on the equivalent residential unit as determined by the size of the reclaimed water meter serving the property as follows:

- (b) Where the reclaimed water service is available but not connected to the property, general customers must ~~shall~~ pay a ~~\$10.48~~ \$10.67 per month reclaimed water base rate.
- (c) Where the reclaimed water service is available but not connected to the property and the customer has a separate potable water irrigation meter, general customers must ~~shall~~ pay a reclaimed water base rate for the equivalent residential unit as determined by the size of the irrigation water meter.
- (4) The monthly base rate for water, sewer, and reclaimed water will ~~shall~~ be applicable, whether occupied or not occupied.
- (5) Customers located outside of the city limits must ~~shall~~ pay a 25 percent surcharge.
- (b) *Monthly Consumption Rates.*

- (a) Single-family residential and commercial customers must ~~shall~~ pay water consumption rates based upon the usage and size of the installed potable water meter as in the following monthly consumption rate/1,000 gallons table below:

- (b) Multifamily residential customers must shall pay the water consumption rates based upon the usage and the number of dwelling units as in the following monthly consumption rate/1,000 gallons table below:

- (c) Single-family residential, multifamily residential, and commercial customers receiving potable water provided through a potable water irrigation meter must shall pay a water consumption rate based upon the size of the installed potable water irrigation meter as follows:

(2) *Sewer consumption rates.*

- (a) Single-family residential and commercial customers must shall pay a sewer usage rate based upon potable water consumption.
- (b) Multifamily residential must shall pay a sewer usage rate based upon potable water consumption and the number of dwelling units.
- (c) Sewer consumption rates for single-family residential customers without a potable water irrigation meter or reclaimed water meter or sub-meter will shall be capped at 10,000 gallons per month.
- (d) Sewer consumption rates for multifamily residential customers without a potable water irrigation meter or reclaimed water meter or sub-meter will shall be capped at 10,000 gallons per month per dwelling unit.
- (e) Sewer consumption rates will shall not be applicable to the use as measured by a potable water irrigation or reclaimed water meter.
- (f) The sewer consumption rate will shall be ~~\$4.03~~ \$4.10 per 1,000 gallons for all customer classes.

(3) *Reclaimed water consumption rates.*

- (a) General and bulk customers must shall pay a reclaimed water consumption rate based upon usage as measured by the reclaimed water meter as follows:

- (b) Customers located outside of the city must ~~shall~~ pay a 25 percent surcharge.

Section 2. That Section 30-336, Stormwater management utility fees, of Appendix "A", Fees and Charges Schedule, is hereby amended to read as follows (with underlining indicating additions and ~~striketrough~~ indicating deletions):

Section 30-336. Stormwater management utility fees.

- (1) Single-family residential, per month ~~\$13.68~~ \$13.93
- (2) Multifamily residential, per unit per month ~~\$13.68~~ \$13.93
- (3) Commercial, per average residential unit per month..... ~~\$13.68~~ \$13.93

Section 3. That Section 32-71, Collection of refuse type I and II, of Appendix "A", Fees and Charges Schedule, is hereby amended to read as follows (with underlining indicating additions and ~~striketrough~~ indicating deletions):

Section 32-71. Collection and disposal of refuse and recyclables:

- (1) *Residential collection rates for refuse type I service.* Minimum rates per year includes two pickups per week:
 - a. Single-family residence, per month ~~\$42.14~~ \$12.33.
 - b. Duplex and triplex residence, per month~~\$10.54~~ \$10.73.
 - c. Multi-family residents (≥4 units):
 1. Multi-family residences using commercial collection for refuse type I service, see rates in (2)a below.
 2. Monthly collection cost for multi-family residences using 96-gallon roll carts, collected twice weekly, will ~~shall~~ be ~~\$28.22~~ \$28.73 per month.

3. Multi-family properties maintaining self-contained or break-away compactors that use roll-off containers will ~~shall~~ be charged ~~\$246.16~~ \$250.59 per pick-up, plus actual disposal fees charged by the Collier County Landfill. A minimum of 48 hours' notice must be given for pickup.
4. Multi-family properties that use containers with wheels will ~~shall~~ be charged an additional ~~\$40.90~~ \$11.10 monthly to off-set the increase in labor required to service wheeled containers, as well as maintenance (repair and replacement) of wheel assemblies.

(2) *Commercial container service collection rates for refuse type I service.*

- b. *Multi-users.* Offices and businesses sharing a container for refuse type I with others will be charged their prorated share of the rate based on the size of container and number of pickups per week as determined by the city manager.

- c. *Change in level of service; size of containers.* The level of service insofar as it relates to the size of container and frequency of collection per week may not be changed more than two times per 12-month period and not closer together than a four-month period of time between changes in level of service. Such change must shall be effectuated by the owner/operator executing proper forms provided by the city and making payment of a \$50.00 fee for effectuating such change; provided, however, that under no circumstances may the level of service and the bi-monthly charge therefore be reduced below the minimum level of service and charge therefore set forth above.
- d. *New accounts.* Billing will commence on new services when an occupancy permit is issued or when the sewer service charge begins, whichever is sooner.
- e. *Compactor and open-top roll-off container servicing.* Commercial properties maintaining self-contained or break-away compactors that use roll-off containers will shall be charged ~~\$246.46~~ \$250.59 per pick-up plus actual disposal fees charged by the Collier County Landfill. A minimum of 48 hours' notice must be given for pickup.
- f. *Annual collection cost for commercial 96-gallon roll carts, collected twice weekly, will* shall be ~~\$28.22~~ \$28.73 per month.
- g. *Commercial properties that use containers with wheels will* shall be charged an additional ~~\$40.90~~ \$11.10 monthly to off-set the increase in labor required to service wheeled containers, as well as maintenance (repair and replacement) of wheel assemblies.
- h. *Collection and disposal of bulk waste.* Customers may request collection of bulk waste, such as furniture and appliances not including any refuse type III C&D debris, by calling the solid waste division. The city manager will establish a specific date within two business days from the customer's request for collection. Customers must shall place all bulk waste curbside for collection no sooner than 24 hours prior to the prearranged collection date. Collection services for bulk waste will shall incur a service charge of ~~\$45.37~~ \$15.65 per cubic yard for collection and disposal with a \$50.00 minimum charge.
- (3) *Collection and disposal of refuse type II.*
- a. Single-family residence, per month, ~~\$4.89~~ \$4.98
- b. Duplex and triplex residence, per month, ~~\$4.08~~ \$4.15
- c. Multi-family residence, per month, ~~\$2.09~~ \$2.13

- d. Volume exceeding four cubic yards~~\$15.37~~ \$15.65 per cubic yard.

- (4) *Collier County landfill disposal charges.* In addition to the above-stated charges for collection of refuse type I, each customer will shall be charged an amount that represents their prorated share of fees charged to the city by Collier County for utilization of the Collier County landfill. This charge will be computed each time landfill charges are changed by the county. Said amount will shall be added to the amounts specified hereinabove on each customer's bill.

- b. Front loading containers with compactors will shall be charged 3 times the rate in subsection (4) a corresponding to the size and pickup rate.
- c. Single-use roll-off containers or compactors will shall be charged their prorated share of disposal fees charged to the city by the county based on the current disposal rate per ton off-loaded at the Collier County Landfill.
- d. Disposal for residential collection services will shall be ~~\$6.08~~ \$6.20 per month.
- e. Disposal for commercial and multi-family roll cart container services will shall be ~~\$12.90~~ \$13.16 per month.

- (5) *Excess waste in containers.* Solid waste placed in containers may not exceed the height of the container. Placing excess waste in containers


~~will~~ shall result in a written warning. The second violation ~~will~~ shall result in an automatic \$50.00 surcharge. Subsequent violations ~~will~~ shall result in container size or frequency of collection being automatically increased in order to provide sufficient service.

- (6) *Collection and processing of residential single stream recyclables.* Minimum rates per year include a city-provided roll cart and 1 pickup per week:
- a. Single-family residence, per month₁ ~~\$0.84~~ \$0.83
 - b. Duplex and triplex residence, per month₁ ~~\$0.72~~ \$0.73
 - c. Multi-family residence, per month₁ ~~\$0.72~~ \$0.73
- (7) *Collection and disposal of incidental amounts of refuse type III C&D debris.* Upon notification from a resident of incidental amounts of C&D debris generated by the resident on their own property, at the discretion of the city manager, the city may choose to collect such materials, pursuant to section 32-34. C&D debris may include cabinets, wood, drywall, plumbing fixtures and other demolition type debris. All loose materials must be in containers, or bags that weigh less than 30 pounds each. No loose piles of material will be collected. The city reserves the right to pick up only those items which employees and equipment are able to safely and effectively collect and dispose. Material approved for collection must be placed curbside no more than 24 hours prior to scheduled collection. Collection services for refuse type III ~~will~~ shall incur a service charge of ~~\$15.37~~ \$15.65 per cubic yard for collection and disposal fee, with a \$50.00 minimum charge.

Section 4. That this resolution will become effective immediately upon adoption. The rates, fees and charges set out herein will become effective October 1, 2019.
