ORDINANCE NO.

AN ORDINANCE TO AMEND THE CODE OF ORDINANCES OF THE CITY OF LOGANVILLE, GEORGIA, CHAPTER 32, "TRAFFIC AND VEHICLES," ARTICLE II, "PARKING," TO PROHIBIT PARKING IN CUL DE SACS OR UPON SIDEWALKS; TO PROHIBIT PERFORMING REPAIR WORK ON THE ROADWAY; TO PROVIDE EXCEPTIONS; TO REPEAL CONFLICTING LAWS; TO PROVIDE AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

THE COUNCIL OF THE CITY OF LOGANVILLE HEREBY ORDAINS:

Section 1. The Code of the City of Loganville, Georgia, is hereby amended by adding a section to be numbered 48, that reads as follows:

"Sec. 32-48. Parking in cul-de-sacs or dead end streets in residential neighborhoods.

No person shall stop, stand or park any vehicle, trailer, boat or other conveyance, required to be registered with the Secretary of State or other governmental agency for use on a public roadway in a cul-de-sac or dead end public street."

Section 2. The Code of the City of Loganville, Georgia, is hereby amended by adding a section to be numbered 49, that reads as follows:

"32-49. Driving and parking over curb or on sidewalk prohibited.

(a) No person shall drive any vehicle upon a sidewalk, sidewalk area, planting strip, shoulder, or over the constructed curbing on a roadway, except upon a permanent or duly authorized temporary driveway.

(b) No person shall park a vehicle across a sidewalk in a manner that in any way obstructs or prohibits use of the sidewalk."

Section 3. The Code of the City of Loganville, Georgia, is hereby amended by adding a section to be numbered 50, that reads as follows:

"32-50. Repair and maintenance prohibited on a public street.

No person shall wash, perform maintenance, or perform repair work on any vehicle parked upon a roadway, except that a person may perform repairs that are necessitated by an emergency."

Section 4. The Code of the City of Loganville, Georgia, is hereby amended by adding a section to be numbered 51, that reads as follows:

"32-51. Exceptions.

(a) The restrictions of Section 32-38 and the restrictions of Sections 32-48 through 32-50 shall not apply to a service vehicle, such as an emergency vehicle (ambulance, police vehicle, fire truck, etc.) while it is providing emergency services at a residence or to a temporarily standing delivery vehicle making deliveries.

(b) The restrictions of Section 32-38 and the restrictions of Sections 32-48 through 32-50 shall not apply to the parking of vehicles performing construction-related activities on a roadway in front of premises where construction is underway, for which construction a current and valid

building permit has been issued by the City of Loganville and said permit is properly displayed on the premises; or on a roadway in front of premises where construction not requiring a building permit (e.g., landscaping) is underway.”

Section 5. The Code of the City of Loganville, Georgia, is hereby amended by adding a section to be numbered 52, that reads as follows:

“Section 32-52. Penalty. Any vehicle parked in violation of this section may be removed in accordance with the tow provisions of the traffic code.”

Section 6. All ordinances or parts of ordinances in conflict with this Ordinance are, to the extent of such conflict, hereby repealed.

Section 7. This ordinance shall become effective on the date of its adoption.
