

**ORDINANCE  
ESTABLISHING LOCATION OF VOTING PLACES  
FOR MUNICIPAL ELECTION**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MILLBROOK,  
ALABAMA, AS FOLLOWS:**

**SECTION 1.** Millbrook Code of Ordinances, Chapter 22 Elections, Article 1, Sec. 22-36. Location of voting places, is deleted in its entirety and replaced by the following:


**Sec 22-36. Location of voting places.**

- (1) Ward 1. Millbrook Fire Station No.1, 3820 Grandview Road
- (2) Ward 2. Millbrook Civic Center, 3168 Park Circle.
- (3) Ward 3. Millbrook Community Players Auditorium, 5720 Main Street.
- (4) Ward 4. TriCity Baptist Church, 4831 AL Highway 14.
- (5) Ward 5. Millbrook Fire Station No.2, 3210 Deatsville Highway.

**SECTION 2.** Should any section or provision of this Ordinance be held invalid, such holding shall not affect any section or provision hereof which is not of itself invalid.

**SECTION 3.** This Ordinance shall become effective upon its adoption and publication as required by law.
