**ORDINANCE AMENDING THE CITY OF MILLBROOK CODE OF ORDINANCES  
SECTION 50-114, ARTICLE IV, CHAPTER 50, BUSINESS LICENSES**

**BE IT ORDAINED BY THE CITY COUNCIL OF MILLBROOK, ALABAMA, as follows:**

	(a) The basic license fee has been paid the city clerk's office.	
	(b) The contractor has furnished either the city building department or the license inspector with a list of names and addresses of all sub-contractors to be used on the project or job. Sub-contractors are those persons who are paid by the contract, by the job, or by the hour and who are not on the contractor's regular payroll. To be on a regular employee payroll, taxes and Social Security must be withheld by the contractor. Each person engaged in the business of accepting orders, contractors or sub-contractors for electrical, plumbing, heating and air-conditioning, sheet metal or other related services shall have a current certification card and pay a license fee as follows:




