ORDINANCE NO. 3187.3

AN ORDINANCE ZONING PARCELS OF PROPERTY LOCATED AT 3721 SHORELINE CIRCLE, (PARCEL IDS: PARCEL IDS: 26788-000-000; 26926-000-000), PANAMA CITY, FLORIDA, HAVING APPROXIMATELY 7.128 ACRES, RESIDNETIAL-2, R-2, PROVIDING FOR SEVERABILITY AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the owners of the parcel of property in the City have requested that the parcels as hereinafter described be zoned Residential-2, R-2; and

WHEREAS, following a public hearing of this ordinance pursuant to the statutes provided and the presentation of competent and substantial evidence and a finding that the requested zoning is consistent with the Comprehensive Plan of the City and serves a public purpose, and that enactment of this ordinance would be proper;

NOW, THEREFORE, BE IT ENACTED BY THE PEOPLE OF THE CITY OF PANAMA CITY, FLORIDA:

MATHIS AND CASPER E. HARRIS TO P. D. RICH, IN THE NW 1/4 OF SECTION 25, TOWNSHIP 3 SOUTH, RANGE 15 WEST, ACCORDING TO PLAT OF ST. ANDREWS BAY RAILROAD LAND AND MINING COMPANY; ALSO, A PARCEL BEGINNING AT THE SOUTHEAST CORNER OF BLOCK 22 IN THE NW 1/4 OF SECTION 25, TOWNSHIP 3 SOUTH, RANGE 15 WEST (ST.
