AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF FORT MYERS, FLORIDA, AMENDING THE CITY CODE, CHAPTER 90, UTILITIES, ARTICLE V. RECLAIMED WATER USE, SECTION 90-151 DEFINITIONS TO PROVIDE FOR FEES TO BE COLLECTED FOR RECLAIMED WATER USE; PROVIDING FOR BACKFLOW PREVENTION DEVICES AND TESTING; PROVIDING FOR BILLING AND OTHER PROCEDURES; AND PROVIDING FOR SEVERABILITY AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF FORT MYERS, FLORIDA, that:

SECTION 1. The City Code of the City of Fort Myers, Florida, Chapter 90 Utilities, Article V. Reclaimed Water Use, Section 90-165 Reclaimed water rates is hereby created to read as follows:

Sec. 90-165. Reclaimed water rates.

There is hereby established the following schedule of rates and charges for the use of the city reclaimed water system:

(a) Application fee: The user shall pay a one hundred fifty dollars (\$150.00) application fee at time of application for connection to the city reclaimed water system.

(b) Monthly charge: The monthly reclaimed water charge shall be based on the actual reclaimed water metered at each user's premise times the bulk reclaimed rate. The bulk reclaimed water rate is as follows:

SECTION 2. Severability. If any section, subsection, sentence, clause, phrase of this ordinance, or the particular application thereof shall be held invalid by any court, administrative agency, or other body with appropriate jurisdiction, the remaining section, subsection, sentences, clauses, or phrases under application shall not be affected thereby.

SECTION 3. Effective Date. This ordinance shall take effect immediately upon adoption as provided by law.
