**ORDINANCE NO. 43-2023**

**ORDINANCE MODIFYING SECTION 60.527 TO REMOVE PERMITTED USES WITHIN  
THE R-4 DISTRICT**

**WHEREAS**, the Village of Godfrey, has a validly established Ordinance regarding zoning controls enacted pursuant to the Illinois Municipal code, 65 ILCS 5/11-13-1 establishing zoning standards and controls within the Village of Godfrey, Madison County, Illinois; and

**WHEREAS**, the Village of Godfrey's zoning ordinance currently provides for community residences in residential districts R-1 through R-5; and

**WHEREAS**, the Village of Godfrey seeks to limit such development in zones R-1 through R-4 and allow such development only by Special Use permit in R-5 zones; and

**WHEREAS**, the health and safety of the residents of the Village of Godfrey require such control over the placement of community residences, and the same is necessary to preserve the character of the existing residential districts; and

**WHEREAS**, the Village Board for the Village of Godfrey after considerable deliberation and thought has determined that the limitation upon community residences to special uses in R-5 multiple-family zoning districts is necessary and in the best interests of the Village.

**NOW THEREFORE, BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES FOR THE VILLAGE OF GODFREY, ILLINOIS, AS FOLLOWS:**

**SECTION ONE:** The above recitals are hereby set forth in this section as findings of fact.

**SECTION TWO:** The existing Appendix A-Zoning Ordinance Section 60.527 – entitled “Permitted Uses Within the R-4 Zoning District” is hereby repealed and replaced in its entirety with the following:

Section 60.527- Permitted Uses Within the R-4 Zoning District

Within the R-4 zoning district, the following uses shall be permitted uses without special permit or authorization. Uses which are not expressly permitted below, or which have not been approved as permitted uses or special uses, upon application, are prohibited:

- (a) Single-family detached dwellings.
- (b) Nonrural home occupations.
- (c) Reserved.
- (d) Family daycare home, subject to the requirements of section 60.214 et seq.

**SECTION THREE:** This Ordinance shall be effective immediately upon its passage and approval in accordance with Illinois law.
