AN ORDINANCE REGARDING THE ILLINOIS PAID LEAVE FOR ALL WORKERS ACT FOR THE VILLAGE OF GODFREY, ILLINOIS

WHEREAS, the Illinois Municipal Code, 65 ILCS 5/1-2-1, provides that the corporate authorities of each municipality may pass all ordinances and make all rules and regulations proper or necessary, to carry into effect the powers granted to municipalities, with such fines or penalties as may be deemed proper; and

WHEREAS, the Village of Godfrey is a non-home rule Illinois municipality; and

WHEREAS, on or about March 12, 2023, Governor JB Pritzker signed into law the Paid Leave for All Workers Act (820 ILCS 192/1 *et seq.*) (the "Act"); and

WHEREAS, the State of Illinois did not make the necessary appropriations or include statutory language exempting the Act from the Illinois State Mandates Act (30 ILCS 805/1 *et seq.*); and

WHEREAS, effective January 1, 2024, the Act requires an employer to provide certain paid leave to their employees, unless the employer is subject to an existing municipal or county ordinance that requires the employer to provide any form of paid leave to their employees; and

WHEREAS, the Village of Godfrey recognizes the importance of paid leave and currently provides reasonable paid leave benefits to its employees; and

WHEREAS, the Village of Godfrey has determined that applying the Act to its own employees will negatively impact the Village of Godfrey, and place an undue financial and operational burden on the Village of Godfrey's ability to provide uninterrupted services to its residents; and

WHEREAS, the Village of Godfrey believes and hereby declares that it is in the best interests of the Village of Godfrey to clearly define the paid leave benefits that the Village of Godfrey employees shall receive.

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF GODFREY, ILLINOIS, AS FOLLOWS:

Section 1: The foregoing recitals shall be and are hereby incorporated as findings of fact as if said recitals were fully set forth herein.

Section 2: Pursuant to Section 15(p) of the Act, the Village of Godfrey hereby adopts the attached paid leave policy for all Village of Godfrey employees as set forth in the Village of Godfrey's Code of Ordinances, Employees Handbook/Policy, Annual Salary Ordinances any collective bargaining agreements to which the Village of Godfrey is a party and all other binding legislative actions governing paid leave adopted by the President and Board of Trustees, as the

same may be amended from time to time. However, in no event shall the Village of Godfrey, as an employer, provide less than one (1) day of paid leave per year to any Village employee.

Section 3: Repeal of Conflicting Provisions. All ordinances, resolutions, and policies or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of conflict, expressly repealed on the effective date of this Ordinance. This Ordinance shall control and have full force and effect upon its passage. A copy of the Village of Godfrey's employee leave policy is attached hereto and fully incorporated and codified herein as Exhibit A.

Section 4: Severability. If any provision of this Ordinance or application thereof to any person or circumstance is ruled unconstitutional or otherwise invalid, such invalidity, shall not affect the other provisions or applications of this Ordinance that can be given effect without the invalid application or provision, and each invalid provision or invalid application of this Ordinance is severable.

Section 5: This section shall be in full force and effect after its passage and publication in pamphlet form by the Village Clerk.
