AN ORDINANCE TO AMEND ORDINANCE NO. 152-N, BEING THE AMENDED ZONING ORDINANCE OF THE TOWNSHIP OF REDFORD, BY AMENDING THE ZONING MAP IN CONNECTION THEREWITH.

THE TOWNSHIP OF REDFORD ORDAINS:

Section 1. The Zoning Map in connection with the Zoning Ordinance of the Charter Township of Redford shall be amended so that the zoning of the following described property to wit:


MAP #4-13: To rezone from C-1 (Local Business District) to C-2 (General Commercial District): Lots 1 through 6, inclusive, SNELL PARK MANOR SUBDIVISION, of part of the SW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 33, T1S, R10E, Redford Township. Property more commonly known as 9092-9088 Telegraph Road, parcel 79-050-03-001-000.

Section 2. All ordinances and parts of ordinances in conflict herewith are repealed hereby to the extent of such conflict.

Section 3. The rezoning was approved by the Board of Trustees, at the Regular Meeting of July 22, 2014. This ordinance shall take effect thirty (30) days after its adoption or upon publication.
