

ORDINANCE 2019-OR3

AN ORDINANCE AMENDING PART OF ARTICLE IX ENTITLED
"STOPPING, STANDING, AND PARKING"
OF MOTOR VEHICLES AND TRAFFIC OF PUBLIC STREETS
AND LIMITING TIMES OF PARKING UPON CERTAIN STREETS
DESIGNATED SNOW AND SWEEPING ROUTES
AND PROVIDING PENALTIES FOR VIOLATIONS THEROF
AND REPEALING ALL OTHER SECTIONS
OF ORDINANCE #914 IN CONFLICT HEREWITH:

WHEREAS, the City of Knox has previously regulated parking within the City of Knox; and

WHEREAS, the regulation of parking is necessary for the health and safety of citizens of Knox; and

WHEREAS, current usage of parking on certain streets has changed over the years so that it is now appropriate to amend prior parking ordinances.

NOW THEREFORE BE IT ORDAINED BY THE COMMON COUCIL OF THE CITY OF KNOX that the code of ordinances of the City of Knox is hereby amended by amending and repealing certain sections of Article IX entitled "Stopping, Standing and Parking" of the City of Knox, as follows:

A) Section 9-441 entitled "Definitions" is hereby amended as follows:

- (a) Snow Emergency. A condition or period of time prior to, during and after a snowfall as forecast by the United States Weather Bureau, during which four (4) inches or more of snow is expected to accumulate, and during which period of time the parking of vehicles could hinder, delay and obstruct the safe flow of traffic and proper cleaning, clearing of heavily traveled public streets.

B) Section 9-442 entitled "Snow Emergency Routes" is hereby amended as follows:

- (a) It shall be unlawful of the owner, driver or operator of any vehicle to park or stop the vehicle, or to permit the vehicle to be parked or stand at any time on any of the following city streets, which are hereby declared to be snow emergency routes.

- C) Section 9-446 entitled "Penalty" be amended as follows: Whoever violates any of the provisions of Section 9-442 shall be fined for each such violation, the sum of \$50.00 for any such violation. Whoever shall violate any of the provisions of Section 9-447 shall be fined for each

such violation the sum of \$25.00. When any police officer or other person authorized by the board of public works and safety shall observe a violation of Sections 9-442 or 9-447 such person or officer may give notice as is provided for in Section 9-444.
