## ORDINANCE 2016-2-2

### AN ORDINANCE AMENDING THE CODE OF ORDINANCES VILLAGE OF ALSIP, ILLINOIS, CHAPTER 19 – TRAFFIC AND MOTOR VEHICLES, ARTICLE IV – MOTOR VEHICLE LICENSES (VEHICLE STICKERS)

---

**WHEREAS**, the Mayor and Board of Trustees have determined it is in the best interests of the Village of Alsip to amend the Municipal Code for the Village of Alsip to increase the price of vehicle stickers;

**NOW THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Alsip, Cook County, Illinois, in the exercise of their home rule powers, as follows:

**Section 1.** Recitals Incorporated. The above recitals are incorporated herein as though fully set forth.

**Section 2.** Municipal Code Amended. The Alsip Village Code, **CHAPTER 19 – TRAFFIC AND MOTOR VEHICLES, ARTICLE IV. - MOTOR VEHICLE LICENSES**, Sections 19-56, 19-57 and 19-59, are hereby amended to read as follows:

#### **Sec. 19-56. - Definitions and classifications.**

For purposes of this article, the following terms shall have the meanings ascribed to them:

**Disabled resident. A village resident with disabilities as evidenced by a current disability verification letter from the Social Security Administration.**

*Handicapped lift vehicle* means a motor vehicle equipped with a lift used for the purpose of allowing the driver or a passenger with a disability to have access to a wheelchair or scooter necessary to provide mobility to that person, but does not include commercial vehicles used for such purpose.

*Motor vehicle*, "Motor vehicle" is hereby defined as every vehicle which is propelled otherwise than by muscular power, including but not limited to motorcycles, motor-driven cycles, reconstructed vehicles, motor tractors, buses, semi-trailers, special mobile equipment, specially constructed vehicles, trailers, trucks and truck tractors. **Motor vehicle classifications shall be determined by the State of Illinois vehicle registration classification for the vehicle.**

~~Motor vehicles which are designed and used for the carrying of not more than seven persons, shall be classified as "motor vehicles of the first division."~~

~~Those motor vehicles that are designed and used for pulling and carrying freight or are used for the carrying of more than seven persons, shall be called "motor vehicles of the second division."~~

**Motor vehicle license sticker.** A sticker license emblem issued by the Village Clerk bearing the words "vehicle license", the name of the village, period of time for which license is issued, the number identical with the number of such license, facsimile signatures of the president and the village clerk and such other insignia as the village may from time to time require.

*Motorcycle.* A "motorcycle" is hereby defined as a motor vehicle having a seat or saddle for the use of the rider and designed to travel on not more than three wheels in contact with the ground, but excluding a tractor.

*Motor-driven cycle.* A "motor-driven cycle" is hereby defined as every motorcycle, including every motor scooter, with a motor which produces not to exceed five horsepower, and every bicycle with motor attached.

#### **Sec. 19-57. - Required.**

It shall be unlawful for any person, firm or corporation residing or housed within the Village of Alsip, County of Cook and State of Illinois, to use, or cause or permit any of his or its agents or employees to use any motor vehicle or motor bicycle upon the streets, avenues or alleys of the village, unless such vehicle is licensed hereinafter as provided.

Residing within the village including the owning, leasing, housing or otherwise controlling of property, including residential or commercial, or business wherein motor vehicles, trailers or semitrailers are stored, repaired, housed, serviced, loaded or unloaded within the village in connection with such business.

Any lost sticker shall be replaced at the full sticker price. Full fee will be refunded to owner if the lost sticker is presented by owner.

~~One senior citizen, who is 62 years of age or older, per household, shall be given a free vehicle sticker for Class A, B or RV vehicle classifications. Said senior citizen must possess a valid Illinois driver's license and the vehicle sticker is for the vehicle owned by the senior. Proof of vehicle ownership and valid driver's license may be required. Additional senior citizens residing in the same household shall be eligible to purchase a vehicle sticker at one-half of the cost provided by this article.~~

#### **Sec. 19-58. - Application.**

Any person desiring a license for a motor vehicle shall file an application with the village clerk upon such form as may be provided by the village, setting forth all information requested on the form.

**Sec. 19-59. - Fees.**

The vehicle license fee to be paid for a 12-month period commencing on July 1, 2016, and each July 1 thereafter, to the village clerk shall be as follows:

(1) For motor cycles ..... ~~\$19.00~~ 25.00

(2) For motor driven cycles .....~~19.00~~ 25.00

(3) For motor vehicles of the first division other than motor cycles or motor driven cycles (commonly referred to as passenger vehicles) and antique vehicles, the vehicle license fee ~~for the year commencing July 1, 2008~~ shall be .....~~27.00~~ 32.00

(4) For motor vehicles of the second division in accordance with the classification under the Illinois Vehicle Code, shall be as follows:

Charitable vehicle (CV plates) .....5.00

Class B ..... ~~32.00~~ 35.00

Class RV ..... ~~31.00~~ 35.00

Class D ..... ~~45.00~~ 50.00

Class H ..... ~~63.00~~ 75.00

**The Village Treasurer shall adjust the fees above every May 1st by indexing the fees to the Illinois Municipal League's Municipal Price Index (MPI), using 2013 as the base value of the MPI. Any such adjustment shall be rounded to the nearest five dollar amount and shall be posted on the Village website.**

(5) One senior citizen, who is 62 years of age or older, per household, shall be given one free vehicle sticker for ~~Class A, B or RV classifications~~ **passenger vehicles or Class B vehicles**. ~~Commencing with the 12 month license period beginning July 1, 2017, one senior citizen, who is 62 years of age or older, per household, shall be given one vehicle sticker for passenger vehicles or Class B vehicles at a cost of \$5.00.~~ Said senior citizen must possess a valid Illinois driver's license and be the registered owner of the vehicle. Proof of vehicle ownership and valid driver's license ~~may shall~~ be required. ~~Additional senior citizens residing in the same household shall be permitted to purchase a vehicle sticker at one-half the cost provided by this article.~~

(6) Disabled citizens shall be entitled to one free sticker, per year, per family for ~~Class A, B, or RV classification~~ **passenger vehicles or Class B vehicles**. A handicapped lift vehicle shall be entitled to a vehicle license without payment of a fee. **Said disabled citizen shall provide both a valid driver's license and appropriate current proof of disability from the Social Security Administration pursuant to Section 19-56 above. Any household that receives a disabled sticker discount on one vehicle shall not be eligible for a senior sticker discount on any vehicle.**

**Section 3. Severability and Repeal of Inconsistent Ordinances.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance. All ordinances in conflict herewith are hereby repealed to the extent of such conflict.

**Section 4. Effective Date.** This Ordinance shall be in full force and effect after its passage and publication as provided by law.
