Council Bill No. B 223-13

AN ORDINANCE

amending Chapters 4, 13 and 28 of the City Code relating to license and permit fees; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. Chapter 4 of the Code of Ordinances of the City of Columbia, Missouri, is hereby amended as follows:

Sec. 4-5. Same—Application.

(a) Any person desiring a license under this chapter shall apply to the business services administrator in writing and under oath. The application shall state:

...

(d) Applications for license renewals should be submitted to the business services administrator no later than May 1. The business services administrator may allow a renewal applicant to continue the manufacture, brewing, sale or distribution of intoxicating liquor or nonintoxicating beer with a temporary license if the renewal application has been submitted to the business services administrator but has not been processed.

(e) For failure to submit a renewal application on or before May 1, a late charge shall be added to the renewal fee as follows:

(1)	<u>May 2 to May 31</u>	<u>\$100.00</u>
(2)	<u>June 1 to June 30</u>	<u>\$200.00</u>
(3)	<u>July 1 and later</u>	<u>\$300.00</u>

SECTION 2. Chapter 13 of the Code of Ordinances of the City of Columbia, Missouri, is hereby amended as follows:

Sec. 13-22. Issuance of licenses.

(a) *Application*. Every person required to procure a license under the provisions of any ordinance or law of the city shall submit an application for such license to the business license administrator. The application shall:

(1) *Form of application*. Be a written statement on forms provided by the business license administrator.

...

(4) *Application fee*. The application shall be accompanied by payment of a fee in the amount of ~~twenty~~ thirty dollars (~~\$20.00~~ \$30.00) plus a fee to cover costs incurred by the department of finance in obtaining the criminal record check required in subsection (b).

...

Sec. 13-55. Fees.

(a) The following table of fees shall apply to this article:

(1) Application or reapplication and testing:.....	\$ 15.00
<u>Security Guards</u>	<u>\$20.00</u>
<u>Armed Guards</u>	<u>\$25.00</u>
(2) Written or shooting retest	10.00

...

SECTION 3. Chapter 28 of the Code of Ordinances of the City of Columbia, Missouri, is hereby amended as follows:

Sec. 28-79. Permits, fees.

(a) It shall be unlawful for any person, corporation or partnership to operate or conduct a taxicab business or limousine service or similar business within the city limits without first obtaining a permit.

(b) It shall be unlawful for any person, corporation or partnership to operate any vehicle for hire within the city limits of Columbia unless that vehicle has a permit issued to it and the vehicle permit fee has been paid. The permit fee shall be twenty-five dollars (~~\$20.00~~ \$25.00) per annum for the first vehicle and ten dollars (~~\$10.00~~) for each additional vehicle.

Sec. 28-113. Qualifications.

(a) Every applicant for a driver's certificate shall:

...

(c) The driver's certificate provided for herein shall not be issued or renewed until the fee for such certificate shall have been paid. The driver's certificate fee shall be ten ~~twenty~~ dollars (~~\$10.00~~ \$20.00) per year. The applicant shall also pay a fee to cover costs incurred by the department of finance in obtaining the criminal record check required in section 28-114.

SECTION 4. This ordinance shall be in full force and effect from and after October 1, 2013.
