ORDINANCE NO. 4137-1-25

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ALLEN, COLLIN COUNTY, TEXAS, AMENDING THE ALLEN LAND DEVELOPMENT CODE AND ZONING MAP, AS PREVIOUSLY AMENDED, BY AMENDING THE USE AND DEVELOPMENT REGULATIONS RELATING TO ILLUMINATED SIGNS ON LOT 6, BLOCK A, KIDS R KIDS ADDITION, BEING A PORTION OF "TRACT 5" OF PLANNED DEVELOPMENT "PD" NO. 53 WITH A BASE ZONING OF SHOPPING CENTER; PROVIDING FOR A CONFLICTS RESOLUTION CLAUSE; PROVIDING A SEVERABILITY CLAUSE; PROVIDING A SAVINGS CLAUSE; PROVIDING A PENALTY OF FINE NOT TO EXCEED THE SUM OF TWO THOUSAND DOLLARS (\$2,000) FOR EACH OFFENSE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Planning and Zoning Commission and the governing body of the City of Allen, Texas, in compliance with the laws of the State of Texas and the Ordinances of the City of Allen, Texas, have given the requisite notices by publication and otherwise, and after holding due hearings and affording a full and fair hearing to all the property owners generally and to all persons interested and situated in the affected area, and in the vicinity thereof, and in the exercise of its legislative discretion, have concluded that Allen Land Development Code Zoning Regulations and Zoning Map of the City of Allen, Texas, as previously amended, should be amended.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ALLEN, COLLIN COUNTY, TEXAS, THAT:

SECTION 1. The Allen Land Development Code Zoning Regulations, as amended ("ALDC"), and the Zoning Map of the City of Allen, Collin County, Texas, as previously amended, be further amended by amending as set forth in Section 2, below, the development regulations relating to the development and use of the property described as Lot 6, Block A, Kids R Kids, an addition to the City of Allen, Collin County, Texas, according to the plat thereof recorded as Instrument No. 20191213010005430, Map Records Collin County, Texas (the "Property"), being a portion of "Tract 5" of Planned Development "PD" No. 53, as set forth in Ordinance No 3672-5-19, and as such regulations have been amended from time to time (collectively, the "PD-53 Regulations").

SECTION 2. The Property shall be developed and used in accordance with the applicable provisions of the ALDC and Tract 5 of the PD-53 Regulations, except to the extent modified by the development and use regulations set forth below:

- **A. ILLUMINATED SIGNAGE.** Illuminated signs may be allowed within 150 feet of a single-family residential district subject to the following:
 - 1. Must be a wall sign;
 - 2. Must be located on the eastern façade directly facing Alma Drive; and
 - 3. Only one (1) illuminated sign is allowed per suite.

SECTION 3. To the extent of any irreconcilable conflict with the provisions of this Ordinance and other ordinances of the City of Allen governing the use and development of the Property and which are not expressly amended by this Ordinance, the provisions of this Ordinance shall be controlling.

SECTION 4. Should any word, sentence, paragraph, subdivision, clause, phrase, or section of this Ordinance, or the Allen Land Development Code Zoning Regulations, as amended hereby, be adjudged or held to be void or unconstitutional, the same shall not affect the validity of the remaining portions of the said Ordinance or the Allen Land Development Code Zoning Regulations, as amended hereby, which shall remain in full force and effect.

SECTION 5. An offense committed before the effective date of this Ordinance is governed by prior law and the provisions of the Allen Land Development Code Zoning Regulations, as amended, in effect when the offense was committed, and the former law is continued in effect for this purpose.

SECTION 6. Any person, firm, or corporation violating any of the provisions or terms of this Ordinance shall be subject to the same penalty as provided for in the Allen Land Development Code Zoning Regulations of the City of Allen, as previously amended, and upon conviction shall be punished by a fine not to exceed the sum of Two Thousand Dollars (\$2,000) for each offense.

SECTION 7. This Ordinance shall take effect immediately from and after its passage and publication in accordance with the provisions of the Charter of the City of Allen, and it is accordingly so ordained.
