

ORDINANCE 2021-03

AN ORDINANCE OF THE CITY OF BELLEAIR BLUFFS, FLORIDA, AMENDING CHAPTER 34 – OFFICERS AND EMPLOYEES TO REVISE MILEAGE REIMBURSEMENT CRITERIA; PROVIDE FOR MONTHLY COMPENSATION PAID TO THE VICE MAYOR; PROVIDE THAT THE CITY ADMINISTRATOR SHALL BE DESIGNATED AS CUSTODIAN OF SUMS WITHHELD FROM COMPENSATION OF OFFICERS AND EMPLOYEES; AND PROVIDING FOR AN EFFECTIVE DATE OF THIS ORDINANCE.

WHEREAS, the City Commission of the City of Belleair Bluffs appointed a Charter and Ordinance Review Committee (“CORC”) to review the Code of Ordinances for legality or obsolescence; and

WHEREAS, the CORC has presented some of its recommendations to the City Commission; and

WHEREAS, the recommendations of the CORC have been found meritorious by the City Commission; and

WHEREAS, the City Commission has received input from the public at two public hearings.

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF BELLEAIR BLUFFS, FLORIDA, IN SESSION DULY AND REGULARLY ASSEMBLED:

Section 1. That Section 34-1(B) of Chapter 34 (Officers and Employees) of the Code of Ordinances of the City of Belleair Bluffs is hereby deleted in its entirety.

Section 2. That Section 34-2(B) of Chapter 34 (Officers and Employees) of the Code of Ordinances of the City of Belleair Bluffs is hereby amended to read as follows:

B. The monthly compensation for each Commissioner or Vice Mayor shall be \$400.00.

Section 3. That Section 34-10 of Chapter 34 (Officers and Employees) of the Code of Ordinances of the City of Belleair Bluffs is hereby amended to read as follows:

Sec. 34-10. - Custodian of funds; reporting agent.

The City Administrator is hereby designated the custodian of all sums withheld from the compensation of officers and employees and of the appropriated funds for the contribution of the city, and the City Administrator is hereby made the withholding and reporting agent and charged with the duty of maintaining personnel records for the purposes of this article.

Section 4. This Ordinance shall become effective immediately upon its final passage and adoption.

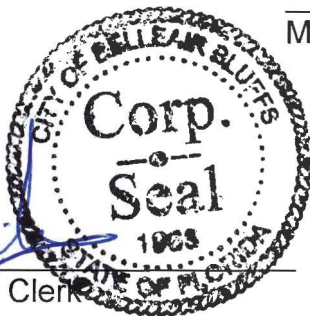
