

Ordinance No. 1165

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SANGER
AMENDING SECTION 90-894 OF DIVISION 2 OF ARTICLE XXIII OF
CHAPTER 90 OF THE SANGER MUNICIPAL CODE, BY ADDING
SUBSECTION 90-894 (7) ESTABLISHING REGULATIONS FOR CARNIVALS
AND SIMILAR EVENTS OPERATED BY CHARITABLE ORGANIZATIONS
TO REQUIRE A DIRECTOR REVIEW PERMIT**

(Zoning Amendment Application No. 2015-01 filed by the City of Sanger)

The City Council of the City of Sanger does ordain as follows.

Section 1. Section 90-894 of Division 2 of Article XXIII of Chapter 90 of the Sanger City Code is amended by adding Subsection (7) to read as follows:

- (7) *Carnivals and similar events.* Carnival activity as defined in Municipal Code Section 18-83 and similar events conducted by charitable organizations that have the potential to attract attendance by more than 100 persons shall require the approval of a Director's Review Permit.

Section 2. The City Clerk shall certify to the adoption of this Ordinance and cause it, or a summary of it, to be published once within 15 days of adoption in a newspaper of general circulation printed and published within the City of Sanger, and shall post a certified copy of this Ordinance, including the vote for and against the same, in the Office of the City Clerk in accordance with Government Code § 36933. Any summary of this Ordinance must be approved by the City Attorney before its publication.

Section 3. **Severability.** If any provision of this Ordinance or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions, or applications of this Ordinance that can be given effect without the invalid provision or application, and to this end, the provisions of this Ordinance are severable. The City Council hereby declares that it would have adopted this Ordinance irrespective of the invalidity of any particular portion thereof.

Section 4. **Effective Date.** This Ordinance shall take effect on the thirty-first (31st) day after its adoption.
