AN ORDINANCE BY THE BOARD OF COMMISSIONERS OF COWETA COUNTY, GEORGIA TO AMEND CHAPTER 14. BUILDINGS AND BUILDING REGULATIONS OF THE COWETA COUNTY CODE OF ORDINANCES AND FOR OTHER PURPOSES

WHEREAS, BE IT ORDAINED by the Commissioners of Coweta County, Georgia that Chapter 14 – Building and Building Regulations of the Coweta County Code of Ordinances has been reviewed; and

WHEREAS, the Board has determined that it is in the best interest of the health, safety and welfare of the public to enact and maintain Building and Building Regulations;

NOW, THEREFORE BE IT ORDAINED by the Commissioners of Coweta County, Georgia; and it is hereby ordained by the authority of the same that Chapter 14 – Building and Building Regulations of the Coweta County Code of Ordinances be amended as follows:

DELETE APPENDIX Permit Fee Schedule (all tables and verbiage at the end of the Chapter) in its entirety.

AMEND Article V. Relocation of Structures, Section 14-118. Expiration of Permit as follows: "Section 14-118. Expiration of Permit to Move a Structure Into or Within Coweta County.

The permit to move a structure into or within Coweta County granted by the building official shall expire upon completion of the move, or in six months, whichever occurs first."

AMEND Article V. Relocation of Structures, Section 14-119. Fees as follows: "Section 14-119. Penalties for Noncompliance.

If a person fails to comply with the requirement to obtain a permit prior to moving a structure into or within Coweta County, the building official may issue a citation to the offender and cause the offender to appear in magistrate court. Violators of this article shall, upon conviction, be punished in section 1-15."

DELETE Article V. Relocation of Structures, Section 14-120. Penalties for Noncompliance in its entirety.

AMEND Article I. In General to **add** the following:

"Section 14-2. Permit Fee Schedule.

From time to time, the Coweta County Board of Commissioners shall set the fees for building construction and for inspection by the building official.

Permit fees for building construction are calculated using the International Code Council Building Valuation Data at a rate of \$4.00 per \$1,000 of calculated construction cost.

Steps to calculate fee:

Step 1: Determine the Construction Type and Occupancy Group from ICC Building Valuation Data.

Step 2: Find the Construction Cost from ICC Building Valuation Data using total square feet of construction.

Step 3: Multiply the Construction Cost by 0.004 to determine the permit fee (\$4.00 per \$1,000 of estimated construction cost).

Building permit fees may be updated periodically to reflect the currently published ICC chart.

Building permit fees include Plan Review and Building Inspections.
