## **ORDINANCE NO. 2023-017**

AN ORDINANCE TO AMEND THE CITY OF JACKSON CODE OF ORDINANCES TO ADD THE JACKSON SQUARE TO THE LIST OF CITY PARKING LOTS; CHAPTER 62: TRAFFIC AND VEHICLES; ARTICLE II: REGULATION OF DOWNTOWN PARKING; SECTION 62-34: CITY PARKING LOTS; TO PROVIDE FOR RELATED MATTERS; TO REPEAL INCONSISTENT PROVISIONS; TO PROVIDE AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS: the City of Jackson (hereinafter referred to as the "City") can exercise all authority granted by the Charter and the laws of the State of Georgia; and

WHEREAS: the City desires to exercise its authority and amend the City's Code of Ordinances to add Jackson Square to the list of city parking lots in the city of Jackson's downtown parking regulations in Chapter 62: Traffic and Vehicles; and

WHEREAS: the Mayor and City Council find that it is in the best interest of the city's administration to adopt these changes; and

THE MAYOR AND CITY COUNCIL OF JACKSON HEREBY ORDAIN THAT THE CODE OF THE CITY OF JACKSON, GEORGIA, SHALL BE AMENDED AS FOLLOWS:

CHAPTER 62: TRAFFIC AND VEHICLES:

ARTICLE II: REGULATION OF DOWNTOWN PARKING

SECTION 62-34: CITY PARKING LOTS

Add this sentence as item #6:

For the purpose of this Ordinance, the Jackson Square is considered a city parking lot. All parking regulations that apply to other city parking lots shall apply to the Jackson Square including the overnight parking restrictions. The parameters for Jackson Square as a city parking lot include all public spaces within these boundaries.

The boundaries of the Jackson Square Business/Entertainment District are as follows: • Mimosa Lane from First Street to Byars Street • Pittman Street from Second Street to Byars Street • Oak Street from First Street to Byars Street • Mulberry Street from First Street to Byars Street • Holley Street from First Street to Byars Street from First Street to Byars Street • Dempsey Avenue from Second Street to East College Street • N. McKibben Street from First Street to Second Street.

All Ordinances in conflict with this ordinance shall be repealed.

SO, BE IT ORDAINED on this 16th day of May 2023.
