

**ORDINANCE NO. 1312**

**AN ORDINANCE OF THE CITY OF KYLE, TEXAS, AMENDING THE CITY'S BUDGET FOR FISCAL YEAR 2023-2024 AS ADOPTED BY ORDINANCE NO. 1285 ON SEPTEMBER 19, 2023, TO AUTHORIZE THE AMENDMENT TO FEE SCHEDULE APPENDIX A FOR BUILDING, ENGINEERING, PARKS, PLANNING, AND PUBLIC WORKS.**

**WHEREAS**, on March 19, 2024, the City Manager presented for the City Council's consideration, a revenue investment savings plan for inspection services as provided by the City's Building Department; and

**WHEREAS**, the fee analysis plan as presented by the City Manager included raising fees for development applications resulting in additional monies to support the existing departments of Building, Planning, Engineering, Parks, and Public Works and their support costs; and

**WHEREAS**, on March 19, 2024, the City Council considered the additional fees for development related applications as presented by the City Manager and supported the City Manager's recommendation to bring back a budget amendment for City Council's approval.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KYLE, TEXAS, THAT:**

**Section 1. Findings of Fact.** The above and foregoing recitals are hereby found to be true and correct and are incorporated herein as findings of fact.

**Section 2. Amendment to Approved Budget.** The City's approved budget for Appendix A Fee Schedule for Fiscal Year 2023-2024 is hereby amended to authorize the changes in Development Review Fees.


**Section 3. Approval of Amendment.** This budget amendment is hereby approved in all aspects and adopted as an amendment to the City's adopted budget for the Fiscal Year beginning October 1, 2023, and ending September 30, 2024.

**Section 4. Repeal of Conflicting Ordinances.** All ordinances or parts thereof conflicting or inconsistent with the provisions of this ordinance as adopted and amended herein, are hereby amended to the extent of such conflict. In the event of a conflict or inconsistency between this ordinance and any other code or ordinance of the City, the terms, and provisions of this ordinance

Open Meetings.** That it is hereby officially found and determined that the meeting at which this ordinance is passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act, Chapter. 551, Tex. Gov't. Code.
