ORDINANCE NO. 1294

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CIBOLO, CANSVASSING THE RETURNS AND DECLARING THE RESULTS OF THE CITY OF CIBOLO'S GENERAL ELECTIONS; AND OTHER MATTERS IN CONNECTION THEREWITH**

**WHEREAS**, the City Council of the City of Cibolo, Texas (the "City") called an election to be held in the City on Tuesday, November 5, 2019, on the races hereafter stated; and

**WHEREAS**, the City Council has investigated all matters pertaining to said election, including the ordering, giving notice, officers, holding and making returns of said election; and

**WHEREAS**, the election officers who held said election have duly made the returns of the result thereof, and said returns have been duly delivered to the City.

**THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CIBOLO, TEXAS THAT:**

**SECTION 1. Compliance with Law.** The City Council officially finds and determines that said election was duly ordered; proper notice of said election was duly given; proper election officers were duly appointed prior to said election; said election was duly held; the City has complied with the Federal Voting Rights Act and the Texas Election Code; returns of the result of said election have been made and delivered; and the City Council has duly canvassed said returns, all in accordance with the law and the Ordinance calling the election.

**SECTION 2. Canvass of Election Returns.** The City Council officially finds and determines that the following votes were cast at said election on the submitted Races by the residents, qualified electors of the City who voted at the election:
