AN ORDINANCE AMENDING TITLE 1, CHAPTER 1.16, SECTION 1.16.010 SCHEDULE OF FINES THE METTER MUNICIPAL CODE

THAT WHEREAS, the City of Metter is duly authorized to operate a police department within its jurisdictional limits to enforce violations of the provisions of its Municipal Code and Rules governing the regulation of motor vehicles as set forth in the Official Code of Georgia; and

WHEREAS, the City of Metter employs personnel to administer and enforce violations thereof through the City's Municipal Court; and

WHEREAS, in order to assist in the financing of these operations and to deter the violations contemplated hereby, the City imposes various fines, fees, charges, and/or penalties; and

WHEREAS, the Mayor and Council have established a Schedule of Fines as part of the City of Metter Municipal Code; and

WHEREAS, the Mayor and Council find it in the best interest of the health, safety, morals, and welfare of the public and the citizenry of Metter to clarify and modify the fines for certain infractions and violations; and

WHEREAS, the Mayor and Council have reviewed the recommended increases in fines as proposed by the Chief of Police and the City Manager;

NOW THEREFORE, BE IT RESOLVED by the Mayor and Council of the City of Metter, Georgia that Title 1, Chapter 1.16, Section 1.16.010 of the Municipal Code of the City of Metter, Georgia is hereby amended to read as follows:

Section 1. Fines and fees of **Section 1.16.010 "Schedule of Fines"** shall be amended as outlined in "Attachment A: Recommended Fines."

Section 2. Except as amended herein, Section 1.16.010 shall otherwise remain unchanged and in full force and effect.

Section 3. This Ordinance shall be and remain in full force and effect from and after its date of adoption on two separate readings.
