AN ORDINANCE OF THE COUNTY COMMISSIONER OF BARTOW COUNTY FOR THE PURPOSE OF AMENDING CHAPTER 18, ARTICLE I OF THE CODE OF BARTOW COUNTY, SECTION 18-3 RELATED TO FEES FOR FIRE MARSHAL ACTIVITIES AND INSPECTIONS AND SECTION 18-4 RELATED TO EMERGENCY ACCESS PROVISIONS AND RELATED MATTERS, ADOPTED AT THE REGULAR MEETING OF THE COMMISSIONER OF BARTOW COUNTY HELD ON NOVEMBER 3, 2021.

WHEREAS, Bartow County amended Chapter 18, Article 1 of the Official Code of Bartow County related to fire safety standards on May 16, 2012, and thereafter amended said Code Section on February 13, 2013, May 20, 2015, December 9, 2015, July 11, 2018 and September 19, 2018 to update said fire safety standards to include emergency access provisions, key lock boxes and related matters and fees for Fire Marshal activities and inspections; and

WHEREAS, the Bartow County Fire Chief and Fire Marshal have recommended additional amendments to said Code Section; and

WHEREAS, the Commissioner deems it to be in the best interest of the citizens of Bartow County to amend the Code as recommended.

NOW THEREFORE, BE IT ORDAINED, and it is hereby ordained, that Chapter 18 of the Code of Bartow County is amended as follows:

False alarms are those alarms caused by faulty detectors that do not get repaired, faulty alarm systems, careless human activity and similar matters. Alarms caused by lightning or other matters beyond human control shall not count towards this penalty. All fines are assessed, during the specified time period, from the date of the first false alarm. Appeal of any fine assessment for false alarms shall be at the discretion of the Bartow County Fire Chief.
