ORDINANCE NO. 53-2022

AN ORDINANCE CONCURRING WITH THE NORTH CAROLINA DEPARTMENT OF TRANSPORTATION FOR SPEED LIMIT REVISIONS INSIDE THE CORPORATE LIMITS OF SHELBY, NORTH CAROLINA

WHEREAS, the City of Shelby has received a request from the North Carolina Department of Transportation for the approval of certification ordinance implementing speed limit modifications on certain state roads within the City Corporate Limits; and,

WHEREAS, the City and the State must concur in this action to modify the speed limits on any state highway located within the limits of the city; and,

WHEREAS, the City Council desires to cooperate with the Department of Transportation in the designation of speed limit modifications as requested;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SHELBY, NORTH CAROLINA:

Section 1. Based upon applicable provisions of the Shelby City Code and an engineering and traffic investigation pursuant to authority granted by GS 20-141(f), the speed zone modifications proposed by the Department of Transportation (DOT) are herby approved as follows:

DECLARE THE FOLLOWING SPEED LIMITS ON US 74

Speed Limit	Route	Description
45 MPH	US 74	(West Dixon Boulevard /East Dixon Boulevard) between a point .100 mile west of SR 1253 (Charles Rd.) and a point .190 mile west of SR 1233 (Link Rd.)
55 MPH	US 74	(West Dixon Boulevard /East Dixon Boulevard) between a point .06 miles east of SR 1396 (Creek Rd.) and a point .1 mile west of SR 1253 (Charles Rd.)

RESCIND THE FOLLOWING SPEED LIMITS ON SR 2583 (WARREN ST)

20 MPH	US 74 BUS (WARREN ST.)	East Warren Street (US 74 Business, NC 150) from South Lafayette Street (NC18-150) to South Dekalb Street (NC 150)

RESCIND THE FOLLOWING SPEED LIMITS ON NC 18

45 MPH	NC 18 (FALLSTON RD.)	NC 18 from a point 0.05 mile south of SR 1930, to the north corporate limit of Shelby at SR 1926.

DECLARE THE FOLLOWING SPEED LIMITS ON SR 1313 (WASHBURN SWITCH RD)

Speed Limit	Route	Description
45 MPH	SR 1313 (WASHBURN SWITCH RD.)	(Washburn Switch Road) between US 74 and a point 0.054 mile southeast of SR 1314, the western corporate limit of Shelby.

RESCIND THE FOLLOWING SPEED LIMITS ON SR 1313 (WASHBURN SWITCH RD)

Speed Limit	Route	Description
45 MPH	SR 1313 (WASHBURN SWITCH RD.)	SR 1313 from the corporate limits of Shelby, a point 1.02 miles north of US 74, to US 74.

DECLARE THE FOLLOWING SPEED LIMITS ON SR 1827 (MCBRAYER SPRING RD)

45 MPH	SR 1827 (MCBRAYER SPRINGS RD.)	(Mcbrayer Springs Road) between a point 0.935 mile south-east of SR 1840 and a point of 1.075 miles south-east of

Section 2. The City Clerk is hereby authorized and directed to cause this Ordinance, and the attached DOT ordinance certifications as ATTACHMENT A, to be certified and forwarded to the Department of Transportation for its use and files for purposes effectuating the stated speed zone modifications.

Section 3. The City Manager or his designees are hereby authorized to execute the applicable documents associated with this ordinance.

Section 4. This ordinance shall become effective upon its adoption and approval both by City and Department of Transportation.
