CITY OF MELVINDALE ORDINANCE NO. 761

AN ORDINANCE TO AMEND ARTICLE I, DIVISION I OF CHAPTER 6 OF THE CITY OF MELVINDALE CODE OF ORDINANCES [BUSINESS LICENSES] AND ARTICLE XIII OF CHAPTER 6 [STREET VENDORS] BY AMENDING SECTIONS 6-5 AND 6-338 RELATED TO APPLICATIONS FOR LICENSES.

THE CITY OF MELVINDALE ORDAINS:

ARTICLE I. Section 6-5 of Chapter 6, Article I, Division 1 of the Code of Ordinances, City of Melvindale, Michigan, is hereby amended to add after subsection 7, the following:

The city clerk may request the Police Department to conduct a background check, including a criminal background check, prior to approving the issuance of a license.

ARTICLE II. Section 6-338 of Chapter 6, Article XIII of the Code of Ordinances, City of Melvindale, Michigan, is hereby amended to add:

- (d) The city clerk may request the Police Department to conduct a background check, including a criminal background check, as part of the application process.
- **ARTICLE III.** Severability: Should any word, sentence, phrase or any portion of this Ordinance be held in a manner invalid by any Court of competent jurisdiction or by any agency having authority to do so for any reason whatsoever, such holding shall be construed and limited to such word, sentence, phrase or any portion of the Ordinance held to be invalid and shall not be construed as affecting the validity of any remaining words, sentences, phrases or portions of the Ordinance.
- **ARTICLE IV.** Conflicting Ordinances: All prior existing ordinances adopted by the City of Melvindale inconsistent or in conflict with the provisions of this Ordinance are, to the extent of such conflict or inconsistency, hereby expressly repealed.
- **ARTICLE V.** Reading and Publication. This Ordinance shall be adopted on August 21, 2013 and shall be effective on August 28, 2013. The City Clerk shall post three (3) copies of the Ordinance in three (3) conspicuous places in the City. The Clerk shall also publish a summary of this Ordinance and include in the publication notice that a true copy of the Ordinance can be inspected or obtained at the City Clerk's office within one week after the adoption of this Ordinance.
