

**ORDINANCE NO. 12-771**

**AN ORDINANCE TO AMEND THE SUMTER COUNTY BUSINESS LICENSE  
ORDINANCE TO PROVIDE FOR ELECTRONIC GAMING AND SIMULATED  
GAMBLING DEVICES**

WHEREAS, Sumter County Council previously enacted Ordinance 92-241, the Sumter County Business License Ordinance, establishing the requirement for all persons engaging in business in the unincorporated areas of Sumter County to obtain an annual business license; and

WHEREAS, the Sumter County Business License Ordinance is codified in Chapter 26, Article II, Sections 26-33 through 26-42 of the Code of Ordinances for Sumter County South Carolina; and

WHEREAS, Sumter County Council recently amended certain parts of the Sumter County Business License Ordinance to include provisions relevant to electronic gaming and simulated gambling devices as an integral part of a business; and

WHEREAS, The Sumter County Business License Office has been asked to account for the revenue generated by Electronic Gaming Establishments and to segregate that revenue from other businesses that may be classified under the Standard Industrial Classification Code 7999

WHEREAS, the Sumter County Business License Office will need to account for revenue received from Electronic Gaming Establishments under a unique numerical code,

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNTY COUNCIL OF  
SUMTER COUNTY, SOUTH CAROLINA, AT ITS REGULAR MEETING DULY  
ASSEMBLED AND BY THE AUTHORITY THEREOF:**

Chapter 26, Article II, Section 26-42 of the Code of Ordinances for Sumter County South Carolina is hereby amended as follows to provide a special numerical code for Electronic Gaming Establishments for accounting purposes:

**Sec. 26-42. Classification rate schedules**

*(4) Class 8 rates.*

7999-9X	Electronic Gaming Establishments \$200 per machine (or “station”); plus	First \$2,000.00	\$50.00 plus
