

ORDINANCE NO. 2019-02-005

AN ORDINANCE AMENDING SECTION 22-7 “PARKS AND RECREATION SERVICES” OF THE CODE OF ORDINANCES BY REVISING VARIOUS FEES; PROVIDING THAT THIS ORDINANCE SHALL BE CUMULATIVE OF ALL ORDINANCES; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of White Settlement is a home rule city acting under its charter adopted by the electorate pursuant to Article XI, Section 5, of the Texas Constitution and Chapter 9 of the Local Government Code; and

WHEREAS, based on the recommendation of the City Manager and city staff, the City Council has reevaluated Park and Recreation Fees; and

WHEREAS, the City Council now deems it appropriate to amend Section 22-7 “Parks and Recreation Services” to accurately reflect the

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WHITE SETTLEMENT, TEXAS:

SECTION 1

Section 22-7 “Parks and Recreation Services” of the Code of Ordinances, City of White Settlement, Texas is hereby amended to read as follows:

SECTION 3

This Ordinance shall be Cumulative of all provisions of Ordinances and of the White Settlement Code of Ordinances, as amended, except where the provisions of this Ordinance are in direct conflict with the provisions of such Ordinances or Code, in which case the conflicting provisions of such Ordinances or Code are hereby repealed.

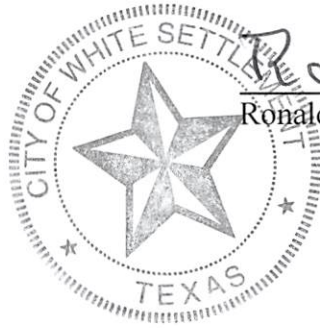
SECTION 4

It is hereby declared to be the intentions of the City Council that the phrases, clauses, sentences, paragraphs and sections of this Ordinance are severable, and if any phrase, clause, sentence, paragraph or section of this Ordinance shall be declared invalid or unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such invalidity or unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this ordinance, since the same would have been enacted by the City Council without the incorporation in this Ordinance of any such invalid or unconstitutional phrase, clause, sentence, paragraph or section.

SECTION 5

This Ordinance shall be in full force and effect after its passage by a majority vote of the City Council of the City of White Settlement and publication as required.
