

## **ORDINANCE NO. 2807**

### **AN ORDINANCE SETTING MEMBERSHIP FEES FOR THE CITY OF HIGHLAND KORTE RECREATION CENTER**

WHEREAS, the City of Highland, Madison County, Illinois (hereinafter “City”), is a non-home rule municipality duly established, existing and operating in accordance with the provisions of the Illinois Municipal Code (Section 5/1-1-1 et seq. of Chapter 65 of the Illinois Compiled Statutes); and

WHEREAS, City has determined it to be necessary to increase membership fees at the Korte Recreation Center to offset increased employment and wage costs, specifically the anticipated increase in minimum wage; and

WHEREAS, City has determined it to be necessary to increase membership fees at the Korte Recreation Center to offset immediate and future costs associated with maintenance of the Korte Recreation Center; and

WHEREAS, City has determined it shall authorize the Korte Recreation Center to increase annual memberships by \$15.00, over and above what is currently being charged, for annual memberships to the Korte Recreation Center; and

WHEREAS, City has determined it shall authorize the Korte Recreation Center to increase three-month memberships by \$5.00, over and above what is currently being charged, for three-month memberships to the Korte Recreation Center; and

WHEREAS, City has determined it to be in the best interests of public health, safety, general welfare and economic welfare to increase membership fees at the Korte Recreation Center; and

WHEREAS, City authorizes the City Manager, and/or Director of Parks and Recreation, to execute any documents necessary to increase membership fees at the Korte Recreation Center as stated herein.

**BE IT HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF HIGHLAND, ILLINOIS AS FOLLOWS:**

- Section 1.* The foregoing recitals are incorporated herein as findings of the City Council of the City of Highland, Illinois.
- Section 2.* The membership fees for the City of Highland Korte Recreation Center shall be as follows, and shall take effect on the dates indicated in *Section 3* and *Section 4* below:

**(A) Resident Pass - Must live inside the Highland City Limits**

**(D) Miscellaneous and program fees to be established by the Director of Parks & Recreation and the Director of Finance with final approval by the City Manager and posted at the Korte Rec Center.**

*Section 3.* The fees for daily passes and 20 Visit Value Cards will remain the same.

*Section 4.* The membership fees for annual passes and 3-month passes will be effective November 1, 2017.

*Section 5.* This ordinance shall be effective upon its passage, approval, and publication in pamphlet form in accordance with law.
