

ORDINANCE NO. 2911

AN ORDINANCE REPEALING AND REPLACING CHAPTER 78-732, SCHEDULE OF FTTP RATES AND CHARGES, SECTION (A), SERVICES BY TELECOM COMPONENT OF FTTP SYSTEM

WHEREAS, the City of Highland, Madison County, Illinois (hereinafter “City”), is a non-home rule municipality duly established, existing and operating in accordance with the provisions of the Illinois Municipal Code (Section 5/1-1-1 et seq. of Chapter 65 of the Illinois Compiled Statutes; and

WHEREAS, from time to time, City makes changes to the services it provides to City Fiber to the Premises (“FTTP”) customers; and

WHEREAS, the Director of Highland Communications Services (“HCS”) has informed the City Council that HCS will be offering new FTTP services, specifically services related to the use of the telephone and all associated telephonic functions; and

WHEREAS, the Director of HCS has informed the City Council that HCS desires to change the rates charged for new FTTP services and existing FTTP services, specifically rates charged regarding the use of the telephone and all associated telephonic functions; and

WHEREAS, City desires to repeal and replace Chapter 78-732, Schedule of FTTP Rates and Charges, Section (A), Services by Telecom Component of FTTP System, to reflect new rates charged to residents for FTTP services, specifically services related to the use of the telephone and all associated telephonic functions; and

WHEREAS, Chapter 78-732, Schedule of FTTP Rates and Charges, Section (A), Services by Telecom Component of FTTP System, currently states:

WHEREAS, City has determined it is in the best interest of public health, safety, general welfare and economic welfare of City to repeal and replace Chapter 78-732, Schedule of FTTP Rates and Charges, Section (A), Services by Telecom Component of FTTP System.

NOW THEREFORE BE IT ORDAINED, by the City Council of the City of Highland, Illinois, as follows:

Section 1. The foregoing recitals are incorporated herein as findings of the City Council of the City of Highland.

Section 2. In the event of conflicts between any provision of this Ordinance and the provisions of any previously adopted and approved Ordinance, the provisions of this Ordinance shall govern.

Section 3. Chapter 78-732, Schedule of FTTP Rates and Charges, Section (A), Services by Telecom Component of FTTP System, and all subsequent amendments are hereby repealed and replaced.

Section 4. Chapter 78-732, Schedule of FTTP Rates and Charges, Section (A), Services by Telecom Component of FTTP System, shall now state:

Section 5. In the event that any portion of this Ordinance is found by a court of competent jurisdiction to be invalid, the remaining portions of this Ordinance are valid, unless the court finds the valid portions of this Ordinance are so essential and inseparably connected with and dependent upon the void portion that it cannot be presumed that the City Council would have enacted the valid portions without the invalid ones, or unless the court finds that the valid portions standing alone are incomplete and are incapable of being executed in accordance with the legislative intent.

Section 6. All ordinances, resolutions or orders, or parts thereof, which conflict with the provisions of this Ordinance, are, to the extent of such conflict, hereby repealed.

Section 7. This Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.
