#### **ORDINANCE NO. 2984**

## AN ORDINANCE AMENDING SECTION 46-40, OF THE CODE OF ORDINANCES, CITY OF HIGHLAND, PERMITTING USE OF NON-INFLATABLE PADDLEBOARDS

WHEREAS, the City of Highland, Madison County, Illinois (hereinafter "City"), is a non-home rule municipality duly established, existing and operating in accordance with the provisions of the Illinois Municipal Code (Section 5/1-1-1 et seq. of Chapter 65 of the Illinois Compiled Statutes); and

WHEREAS, City has determined there is a demand for the use of paddleboards on City Silver Lake; and

WHEREAS, City has determined the use of paddleboards on City Silver Lake must be authorized and licensed so as not to conflict with the current Silver Lake Ordinance, specifically:

1. Sec. 46-37. - Boats and boating.

2. Sec. 46-42. - Swimming, diving, skiing, ice skating.

#### and

WHEREAS, City has determined it prudent to create a specific section of the Silver Lake Ordinance dealing specifically with the use of paddleboards on City Silver Lake; and

WHEREAS, Section 46-40 of the Silver Lake Ordinance is Reserved, and currently states:

Sec. 46-40. - Reserved.

### and

WHEREAS, City has determined the Silver Lake Ordinance, Section 46-40, of the City Code of Ordinances shall now state:

Sec. 46-40. – Non-Inflatable Paddleboards

- (a) Non-Inflatable Paddleboards shall be permitted on City Silver Lake pursuant to this Ordinance, Sec. 46-40. Non-Inflatable Paddleboards.
- (b) All Non-Inflatable Paddleboards are subject to Sec. 46-37 Boats and boating, (a) Boat licenses, and shall be classified as "non-motorized" for assessment of fees.
- (c) All Non-Inflatable Paddleboards are subject to Sec. 46-37 Boats and boating, (a) Boat licenses, and all licensees shall fill out an application and be licensed by City.

- (d) All Non-Inflatable Paddleboard licensees must sign a liability waiver with City as part of the licensure process. The liability waiver must list all potential users of the Non-Inflatable Paddleboard and must be signed by all potential users of the Non-Inflatable Paddleboard.
- (e) Non-Inflatable Paddleboards shall not be used on City Silver Lake by any person who has not signed a liability waiver with City and is not in possession of a valid City license.
- (f) All Non-Inflatable Paddleboard licensees shall not violate Sec. 46-42. Swimming, diving, skiing, ice skating, except where necessary to use the Non-Inflatable Paddleboard, and shall not remain in the City Silver Lake water for more time than necessary to mount and dismount the Non-Inflatable Paddleboard.

and

WHEREAS, City has determined it is in the best interests of public health, safety, general welfare and economic welfare to amend Sec. 46-40 to permit Non-Inflatable Paddleboards pursuant to this Ordinance; and

WHEREAS, City has determined the City Manager and/or Mayor is authorized and directed to execute whatever documents may be necessary to amend Sec. 46-40 to permit Non-Inflatable Paddleboards pursuant to this Ordinance.

# NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Highland as follows:

Section 1. The foregoing recitals are incorporated herein as findings of the City Council of the City of Highland, Illinois.

Section 2. City has determined Section 46-40, shall now state:

Sec. 46-40. - Non-Inflatable Paddleboards

- (a) Non-Inflatable Paddleboards shall be permitted on City Silver Lake pursuant to this Ordinance, Sec. 46-40. Non-Inflatable Paddleboards.
- (b) All Non-Inflatable Paddleboards are subject to Sec. 46-37 Boats and boating, (a) Boat licenses, and shall be classified as "non-motorized" for assessment of fees.

- (c) All Non-Inflatable Paddleboards are subject to Sec. 46-37 Boats and boating, (a) Boat licenses, and all licensees shall fill out an application and be licensed by City.
- (d) All Non-Inflatable Paddleboard licensees must sign a liability waiver with City as part of the licensure process. The liability waiver must list all potential users of the Non-Inflatable Paddleboard and must be signed by all potential users of the Non-Inflatable Paddleboard.
- (e) Non-Inflatable Paddleboards shall not be used on City Silver Lake by any person who has not signed a liability waiver with City and is not in possession of a valid City license.
- (f) All Non-Inflatable Paddleboard licensees shall not violate Sec. 46-42. Swimming, diving, skiing, ice skating, except where necessary to use the Non-Inflatable Paddleboard, and shall not remain in the City Silver Lake water for more time than necessary to mount and dismount the Non-Inflatable Paddleboard.

*Section 3.* This ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.
