

On joint motion of all Councilmembers present the following ordinance was offered:

SUMMARY NO. 24084 ORDINANCE NO. 24789

An ordinance revoking ordinance no. 23584 and dissolving the hospital service district within the Parish of Jefferson known as the "Jefferson Parish Hospital and Health Services District, Parish of Jefferson, State of Louisiana" and to provide for related matters.
(Parishwide)

THE JEFFERSON PARISH COUNCIL HEREBY ORDAINS:

SECTION 1: That under and by virtue of the authority conferred by LSA Const. Art. 6 § 19, Paragraph (7) of Section 2.01, Article 2 of the Jefferson Parish Home Rule Charter, and Chapter 10, Title 40 of the Louisiana Revised Statutes of 1950 (La. R.S. 46:1051 et seq.), the Jefferson Parish Council, acting on its own initiative, hereby dissolves the hospital service district within the Parish of Jefferson known as the "Jefferson Parish Hospital and Health Services District, Parish of Jefferson, State of Louisiana"

SECTION 2: That Ordinance no. 23584 is hereby revoked.

SECTION 3: That Sections 2-861 and 2-862 of the Jefferson Parish Code of Ordinances are hereby repealed.

SECTION 4: That Section 2-891 of the Jefferson Parish Code of Ordinances is hereby amended as follows:

Sec. 2-891. Established

(a) There is hereby established a uniform set of procedures for the purchase of labor, materials, supplies, equipment, services and public works by the purchasing department for all departments of the parish as provided in this division.

(b) The following special districts are exempt from the Jefferson Parish procurement procedures:

- (1) The Jefferson Parish Communication District;
- (2) Jefferson Parish Hospital Service District No. 1;
- (3) Jefferson Parish Hospital Service District No. 2;
- ~~(4) Jefferson Parish Hospital and Health Services District;~~
- ~~(5)~~ (4) Jefferson Parish Economic Development and Port District (JEDCO).

SECTION 5: That Section 17-14 of the Jefferson Parish Code of Ordinances is hereby repealed.

SECTION 6: That Section 17-18 of the Jefferson Parish Code of Ordinances is hereby amended as follows:

Sec. 17-18. Meetings of governing authority.

The parish council acting as governing authority of ~~Jefferson Parish Hospital and Health Services District~~, Jefferson Parish Hospital Service District No. 1, and Jefferson Parish Hospital Service District No. 2 shall conduct the respective hospital service districts business at an appropriate time during the parish council meeting as indicated on the meeting agenda.

SECTION 7: That Section 17-19 of the Jefferson Parish Code of Ordinances is hereby amended as follows:

Sec. 17-19. Rules and procedures. All the rules and procedures set out for handling business items of ~~Jefferson Parish Hospital and Health Services District~~, Jefferson Parish Hospital Service District No. 1, and Jefferson Parish Hospital Service District No. 2, including but not limited to the expenditure of funds, shall be the same as the parish council rules and procedures appropriate to the category in which ~~Jefferson Parish Hospital and Health Services District~~, Jefferson Parish Hospital Service District No. 1, and Jefferson Parish Hospital Service District No. 2 appear on the meeting agenda of the parish council.

SECTION 8: That the Council Chairman, or in his absence the Vice-Chairman, is authorized to sign any and all documents required to carry out the provisions of this ordinance.

The foregoing ordinance having been submitted to a vote, the vote thereon was as follows:

The ordinance was declared to be adopted on this the 23rd day of July, 2014, and shall become effective as follows; if signed forthwith by the Parish President, ten (10) days after adoption, thereafter upon signature by the Parish President, or, if not signed by the Parish President, upon expiration of the time for ordinances to be considered finally adopted without the signature of the Parish President, as provided in Section 2.07 of the Charter. If vetoed by the Parish President and subsequently approved by the Council, this ordinance shall become effective on the day of such approval.
