

**CHARTER TOWNSHIP OF MUNDY**

**ORDINANCE NO. 198-20**

AN ORDINANCE TO AMEND AND CLARIFY ORDINANCE 198, AND AMENDMENTS THERETO, RELATING TO THE FEES FOR FIRE SERVICES ALLOWED BY STATE LAW, SPECIFICALLY BEING MCL 41.806A, AND THE PROVISIONS OF THE TOWNSHIP ORDINANCES TO RECOVER COSTS FOR FIRE SERVICES.

**THE CHARTER TOWNSHIP OF MUNDY HEREBY ORDAINS:**

**SECTION I.           APPLICABILITY**

The provisions exempting the charging of fees by the Fire Department shall be added the following language:

- A.     Fires of property, real or personal, located within the geographic boundaries of the Township that are not intentionally caused fires, which were started by the resident or property owner of that property.
  
- B.     Medical calls for residents or calls to the property of a resident.

**SECTION II.         FEES**

- A.     The fees and collections shall be as follows:
  - 0.     The fees and the collection of those fees for any response to a situation by the Fire Department, the owner and operator, and any other person or entity having control of the object for which the circumstance or situation caused the Fire Department to respond shall pay:
    - (a) Fee of \$450.00 per hour for a pumper truck;
  
    - (b) Fee of \$250.00 per hour for a squad truck; and
  
    - (c) Fee of \$710.00 per hour for the aerial truck; and
  
    - (d) Fee of \$90.00 per hour for any command vehicle;

(e) The actual fees paid to individuals responding to the situation, based upon the wages paid; and

(f) The actual cost of replacement for any supplies or materials used.

1. Within thirty (30) days after a response, the Fire Chief shall cause to be issued a statement of the fees and basis for such. That statement shall be payable within thirty (30) days of the date of the statement.

### **SECTION III. CONTESTING STATEMENT AND APPEAL**

A. Any person or entity who disagrees with the statement for costs as sent by the Fire Chief may seek to resolve the disagreement with the Township Manager within thirty (30) days of the date of the statement, by filing a written statement as to why they disagree. The Township Manager, in the Township Manager's discretion, may adjust the amount of the statement, based upon the circumstances presented.

B. Any person or entity who wishes to further contest the determination of the Fire Chief, as to the costs to be assessed, shall appeal that determination, in writing, to the Township Board of Appeals within thirty (30) days of the date of the decision of the Township Manager. Such writing shall specify, in detail, why the person disagrees with that decision.

### **SECTION IV. EFFECTIVE DATE**

This ordinance shall become effective immediately upon passage by the Township Board and publication thereof.
