Ordinance No. 329-C

**AN ORDINANCE TO AMEND THE CODE OF THE CITY OF
FLAT ROCK BY AMENDING SECTION 58-402 AND ADDING
SECTION 58-405 PERTAINING TO MUNICIPAL CIVIL
INFRACTIONS.**

THE CITY OF FLAT ROCK ORDAINS:

SECTION I. Section 58-402 of Chapter 58 of the Code of the City of Flat Rock is hereby amended to read as follows:

Sec. 58-402. Municipal civil infractions.

It is hereby determined that the violation of any of the following ordinance provisions shall constitute a municipal civil infraction punishable by civil fines as established by resolution of the city council:

- (a) Chapter 18, Building and Building Regulations:
 - Article I - In General
 - Article II - State Construction Code
 - Article III - Electrical Code
 - Article IV - Smoke Detection Devices
 - Article V - Swimming Pools
 - Article VI - Property Maintenance Code
 - Article VII - Dangerous Buildings
- (b) City of Flat Rock Zoning Ordinance
- (c) Chapter 42, Fire Prevention and Protection:
 - Article II - Fire Prevention Code

- (d) Chapter 14, Animals
 - Article II - Dogs
 - Article III - Cats
- (e) Chapter 38, Environment
 - Article VI - Storm Water Management
- (f) Any other ordinance which specifically provides that a violation constitutes a municipal civil infraction.

SECTION II. That Article X of Chapter 58 of the Code of the City of Flat Rock is hereby amended by adding a new section, which new section shall be designated as Chapter 58-405, to read as follows:

Sec. 58-405. Failure to answer.

A defendant who fails to answer a citation or notice to appear in court for a municipal civil infraction shall be guilty of a misdemeanor, punishable by a fine of not more than \$500.00 and the cost of prosecution, or by imprisonment for not more than 90 days, both such fine, cost, and imprisonment in the discretion of the court.

SECTION III. That all ordinances or parts of ordinances, Code of the City of Flat Rock, or parts of the Code of the City of Flat Rock, not consistent herewith are hereby repealed.

SECTION IV. This ordinance shall be published in the News Herald newspaper as required by Charter on the 30th day of July, 2008, but in no event shall be effective earlier than ten (10) days after enactment.
