Dear Mayor and Council:

Enclosed please find proposed Ordinance, as recommended by Chief Leacher and Chief Vack in the regulation and control of the sale of marijuana within the City of Flat Rock. Please note that the proposed ordinance applies solely to the sale of marijuana within the City. The ordinance has no effect as to the use or consumption of marijuana within the City. The ordinance has no effect as to the use or consumption of marijuana by individuals, 21 years of age or older. Under the new provision, persons 21 years of age or older may use or consume, internally possess, purchase, transport, or possess 2.5 ounces or less of marijuana.

Ordinance No. 445

**AN ORDINANCE TO AMEND CHAPTER 22 OF THE CODE
OF THE CITY OF FLAT ROCK BY ADDING ARTICLE XVI,
PROHIBITING THE ESTABLISHMENT OR OPERATION OF
MARIJUANA AS DEFINED BY THE MICHIGAN
REGULATION AND TAXATION OF MARIJUANA ACT**

THE CITY OF FLAT ROCK ORDAINS:

SECTION I. Chapter 22 of the Code of the City of Flat Rock is hereby amended, adding Article XVI, prohibiting the establishment or operation of a marijuana establishment as defined by the Michigan Regulation and Taxation of Marijuana Act, to read as follows:

Section 22-700. The purpose of this chapter is to exercise the City of Flat Rock's authority to prohibit the establishment or operation of marijuana establishments with the City as such facilities are defined by the Michigan Regulation and Taxation of Marijuana Act (the "Act").

Section 22-701. Pursuant to the Act, Section 6.1, the City of Flat Rock prohibits the establishment or operation of any and all categories of marijuana establishments within its boundaries.

SECTION II. That all ordinances or parts of ordinances, the Code of the City of Flat Rock, or parts of the Code of the City of Flat Rock, not consistent herewith are hereby repealed.

SECTION III. This ordinance or a summary thereof shall be published in the News Herald newspaper as required by Charter on the _____ day of _____, 2018, but in no event shall be effective earlier than ten (10) days after enactment.
