Ordinance to Amend and Re-Enact Article III of Chapter 12 of the City Code of the City of Hampton, Virginia Entitled, "Precinct Voting Places" to Change the Name of Certain Election Polling Places to be Consistent with Name Changes Adopted by the Hampton School Board in 2021 and to Make Technical Changes to the Article

WHEREAS, on May 19, 2021, the Hampton School Board adopted a motion to rename five (5) Hampton City schools as follows: Booker Elementary to Albert W. Patrick III Elementary; Cary Elementary to Mary T. Christian Elementary; Spratley Gifted Center to Ann H. Kilgore Gifted Center; Tucker-Capps Fundamental Elementary School to Mary W. Jackson Fundamental Elementary; and Tyler Elementary to Mary S. Peake Elementary;

WHEREAS, three (3) of the five (5) re-named schools-Albert W. Patrick III Elementary, Mary W. Jackson Fundamental Elementary, and Mary S. Peake Elementary-are designated as election precinct polling places by Chapter 12 of the City Code;

WHEREAS, the Hampton Electoral Board has requested that the City Council update the name of the election polling places and precincts to be consistent with the 2021 Hampton School Board action to rename the schools;

WHEREAS, no changes to the boundaries of any election precincts or locations of any polling places shall result from this change, rather, only name-changes;

WHEREAS, upon adoption of this ordinance, the General Registrar is required by Section 24.2-306 of the Code of Virginia to mail individual notice to all voters affected by the name change at least 15 days before the next primary, special, or general election in order to inform them of the change; and

WHEREAS, the City Council has determined that amending the names of the election polling places in a manner consistent with the 2021 Hampton School Board action is in the best interest of voters.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Hampton, Virginia that Chapter 12 of the City Code of the City of Hampton, Virginia, be amended and re-enacted as follows:

Chapter 12 - ELECTIONS

ARTICLE III. - PRECINCT POLLING PLACES

Sec. 12-56. - Wythe precinct.

The polling place in the Wythe precinct shall be located at the Senior Citizens Center, 3501 Kecoughtan Road.

Sec. 12-57. - Armstrong precinct.

The polling place in the Armstrong precinct shall be located at Armstrong School, 3401 Matoaka Road.

Sec. 12-58. - Phenix precinct.

The polling place in the Phenix precinct shall be located at the Kenny Wallace Resource Center, 2315 Victoria Boulevard.

Sec. 12-59. - Bassette precinct.

The polling place in the Bassette precinct shall be located at A.W.E. Bassette School, 671 Bell Street.

Sec. 12-60. - Lindsay precinct.

The polling place in the Lindsay precinct shall be located at the C. Alton Lindsay Middle School, 1636 Briarfield Road.

Sec. 12-61. - Mallory precinct.

The polling place in the Mallory precinct shall be located at Francis Mallory School, 331 Big Bethel Road.

Sec. 12-62. - Aberdeen precinct.

The polling place in the Aberdeen precinct shall be located at Aberdeen School, 424 Aberdeen Road.

Sec. 12-63. - Kraft precinct.

The polling place in the Kraft precinct shall be located at Christopher Kraft School, 600 Concord Drive.

Sec. 12-64. - Jackson precinct.

The polling place in the Jackson precinct shall be located at Mary W. Jackson Fundamental Elementary School, 113 Wellington Drive.

Sec. 12-65. - Bethel precinct.

The polling place in the Bethel precinct shall be located at Bethel High School, 1067 Big Bethel Road.

Sec. 12-66. - Cooper precinct.

The polling place in the Cooper precinct shall be located at William M. Cooper School, 200 Marcella Road.

Sec. 12-67. - Burbank precinct.

The polling place in the Burbank precinct shall be located at Paul Burbank School, 40 Tide Mill

Lane.

Sec. 12-68. - Peake precinct.

The voting place in the Peake precinct shall be located at Mary S. Peake Elementary School, 57 Salina Street.

Sec. 12-69. - Thomas precinct.

The polling place in the Thomas precinct shall be located at the Y. H. Thomas Recreational Facility, 1300 Thomas Street.

Sec. 12-70. - Patrick precinct.

The polling place in the Patrick precinct shall be located at Albert W. Patrick III Elementary School, 160 Apollo Drive.

Sec. 12-71. - Phillips precinct.

The polling place in the Phillips precinct shall be located at Phillips School, 703 LeMaster Avenue,

Sec. 12-72. - Kecoughtan precinct.

The polling place in the Kecoughtan precinct shall be located at Kecoughtan High School, 522 Woodland Road.

Sec. 12-73. - Asbury precinct.

The polling place in the Asbury precinct shall be located at Francis Asbury School, 140 Beach Road.

Sec. 12-74. - Bryan precinct.

The polling place in the Bryan precinct shall be located at Jane H. Bryan School, 1021 North Mallory Street.

Sec. 12-75. - Smith precinct.

The polling place in the Smith precinct shall be located at Captain John Smith School, 379 Woodland Road.

Sec. 12-76. - Phoebus precinct.

The polling place in the Phoebus precinct shall be located at the Phoebus Branch Library, 1 South Mallory Street.

Sec. 12-77. - Main Library precinct.

The polling place in the Main Library precinct shall be located at the Hampton Public Library, 4207 Victoria Boulevard.

Sec. 12-78. - Langley precinct.

The polling place in the Langley precinct shall be located at Samuel P. Langley School, 16 Rockwell Road.

Sec. 12-79. - Syms precinct.

The polling place in the Syms precinct shall be located at Benjamin Syms Middle School, 170 Fox Hill Road.

Sec. 12-80. - City Hall precinct.

The polling place in the City Hall precinct shall be located at Hampton City Hall, 22 Lincoln Street.

Sec. 12-81. - Machen precinct.

The polling place in the Machen precinct shall be located in Luther W. Machen School, 20 Sacramento Drive.

Sec. 12-82. - Forrest precinct.

The polling place in the Forrest precinct shall be located in Alfred S. Forrest School, 1406 Todds Lane.

Sec. 12-83. - Jones precinct.

The polling place in the Jones precinct shall be located in Jones Magnet Middle School, 1819 Nickerson Boulevard.

Sec. 12-84. - East Hampton precinct.

The polling place in the East Hampton precinct shall be located at Phoebus High School, 100 Ireland Street.

Sec. 12-85. - Sandy Bottom precinct.

The polling place in the Sandy Bottom precinct shall be located at the Nature Center, Sandy Bottom Nature Park, 1255 Big Bethel Road.
