

**ORDINANCE OF THE MAYOR AND BOARD OF ALDERMEN
OF THE CITY OF OLIVE BRANCH, MISSISSIPPI
ESTABLISHING STORMWATER APPLICATION REVIEW FEE**

An Ordinance adopting and establishing fees for the City of Olive Branch for stormwater application review pursuant to the Stormwater Controls and Management Practices Ordinance of 2005

BE IT ORDAINED, by the Mayor and Board of Aldermen of the City of Olive Branch, Mississippi:

WHEREAS, the Mayor and Board of Aldermen of the City of Olive Branch adopted a Stormwater Controls and Management Practices Ordinance for the City of Olive Branch, Mississippi on November 15, 2005, and

WHEREAS, Section 6 of said Stormwater Ordinance contains the permit procedures and requirements, and

WHEREAS, Section 6-1.1 states that a permit for land development disturbance activities must be accompanied by a non-refundable permit review fee established by the City of Olive Branch, and

WHEREAS, Section 6-1.2 of the Stormwater Ordinance states that the "fee for review of any land development application shall be based on the amount of land to be disturbed at the Site, and the fee structure shall be established by the City of Olive Branch," and

WHEREAS, Steve Bigelow, City Engineer, in conjunction with engineers for other municipalities across DeSoto County, has recommended the adoption of a Stormwater Permit Fee of \$100.00 per acre with no maximum, said fee to be effective January 1, 2007, and

WHEREAS, the administrative burden of reviewing applications increases with the size of the site to be developed, in that the City of Olive Branch will incur administrative expense in not only reviewing the plans but also inspecting the actual site of development, and

WHEREAS, the Mayor and Board of Aldermen find that it is in the best interest of the citizens that it adopt a Stormwater Application Review Fee of \$100.00 per acre, with no maximum, to be effective January 1, 2007.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Aldermen of the City of Olive Branch, Mississippi as follows, to wit:


1. That a Stormwater Application Review Fee, established pursuant to Section 6-1.2 of the Stormwater Controls and Management Practices Ordinance for the City of Olive Branch, in the amount of \$100.00 per acre, with no maximum, to be effective January 1, 2007, be, and the same is hereby adopted by the City of Olive Branch.

Passage of this Ordinance is now official and the same shall take effect and be enforced as provided by law.


