

ORDINANCE NO. 1477-18

AN ORDINANCE AMENDING SECTIONS 7.2 & 7.3 OF THE UNIFIED DEVELOPMENT CODE OF THE CITY OF MILTON, UPDATING THE USE DEFINITIONS TO PROVIDE A DEFINITION FOR PERMANENT MAKEUP SERVICES, AND UPDATING THE USE MATRIX TO ALLOW PERMANENT MAKEUP SERVICES AS AN ALLOWABLE ANCILLARY USE WITHIN BEAUTY SALONS, DOCTORS OFFICES AND EDUCATIONAL INSTITUTIONS; PROVIDING FOR SEVERABILITY; REPEALING ALL ORDINANCES IN CONFLICT HEREWITH AND PROVIDING FOR AN EFFECTIVE DATE.

NOW THEREFORE BE IT ORDAINED BY THE City Council of the City of Milton, Florida as follows:

Section 1: Unified Development Code Amendment.

The City of Milton Code of Ordinances is hereby amended as set forth in and incorporated herein by reference.

Section 7.2 Use Definitions.

Permanent Makeup Services – Permanent makeup is otherwise known as cosmetic tattooing, and includes the application of permanent eyeliner, eyebrows, full lip color, re-pigmentation or camouflage using tattooing techniques of placing pigments under the skin. Permanent makeup services shall only be allowed within body modification establishments as defined, except as provided in this ordinance.

Section 4: Effective Date.

This Ordinance shall be effective upon passage by the City Council.


