5	THE COUNCIL OF THE CITY OF LONGMONT, COLORADO, ORDAINS:		
6	Section 1		
7	In this ordinance, ellipses indicate material not reproduced as the Council intends to leave		
8	that material in effect as it now reads.		
9	Section 2		
10	The Council amends section 2.20.010 of the Longmont Municipal Code, by adding		
11	italicized material and deleting stricken material, to read as follows:		
12	2.20.010. – Departments established.		
13	Pursuant to the provisions of section 6.5 of the Charter, there are established		
14	administrative departments, as follows: external services; nextlight; shared		
15	services; finance and support services; economic development; city power and		
16	communications; community services; public safety; and utilities and public works		
17	and natural resources. The organizational structure within each administrative		
18	department shall consist of such bureaus, divisions, offices, sections, programs,		
19	agencies and other units as otherwise more specifically set forth as to structure,		
20	function and duties by direction of the city manager. Whenever this Code refers to		
21	the director or other official of a department, that person shall be deemed to be the		
22	city manager or the manager's designee. The city manager is authorized to		
23	promulgate an administrative regulation designating the director and other officials		

1	of each city department. In all instances, references in this Code to a particular		
2	director or official shall be to that person or position as set out in the adopted		
3	regulation.		
4	Section 3		
5	The Council amends section 2.20.020 of the Longmont Municipal Code, by adding		
6	italicized material and deleting stricken material, to read as follows:		
7	2.20.020. – Community recreation program.		
8	A. Pursuant to section 3.14 of the Charter, the council hereby creates a		
9	community recreation programservice area, titled recreation, as part of the		
10	external community services department. That service area shall be responsible for		
11	planning and implementing a community recreation program.		
12	B. Pursuant to section 3.14 of the Charter, the council will provide for		
13	equipping, financing and maintaining city-owned or controlled parks, recreation		
14	areas and facilities in and outside the corporate limits of the city in its annual		
15	appropriation ordinance.		
16	Section 3		
17	To the extent only that they conflict with this ordinance, the Council repeals any conflicting		
18	ordinances or parts of ordinances. The provisions of this ordinance are severable, and invalidity of		
19	any part shall not affect the validity or effectiveness of the rest of this ordinance.
