

ORDINANCE O-2023-02

A BILL FOR AN ORDINANCE AMENDING CHAPTER 2.20 OF THE LONGMONT
MUNICIPAL CODE RELATED TO CITY DEPARTMENTS

THE COUNCIL OF THE CITY OF LONGMONT, COLORADO, ORDAINS:

Section 1

In this ordinance, ellipses indicate material not reproduced as the Council intends to leave that material in effect as it now reads.

Section 2

The Council amends section 2.20.010 of the Longmont Municipal Code, by adding italicized material and deleting stricken material, to read as follows:

2.20.010. – Departments established.

Pursuant to the provisions of section 6.5 of the Charter, there are established administrative departments, as follows: *external services; nextlight; shared services;* ~~finance and support services; economic development; city power and communications; community services;~~ public safety; and *utilities and* public works ~~and natural resources~~. The organizational structure within each administrative department shall consist of such bureaus, divisions, offices, sections, programs, agencies and other units as otherwise more specifically set forth as to structure, function and duties by direction of the city manager. Whenever this Code refers to the director or other official of a department, that person shall be deemed to be the city manager or the manager's designee. The city manager is authorized to promulgate an administrative regulation designating the director and other officials

of each city department. ~~In all instances, references in this Code to a particular director or official shall be to that person or position as set out in the adopted regulation.~~

Section 3

The Council amends section 2.20.020 of the Longmont Municipal Code, by adding italicized material and deleting stricken material, to read as follows:

2.20.020. – Community recreation program.

A. Pursuant to section 3.14 of the Charter, the council hereby creates a *community recreation program* ~~service area, titled recreation~~, as part of the *external* ~~community~~ services department. That service area shall be responsible for planning and implementing a community recreation program.

B. Pursuant to section 3.14 of the Charter, the council will provide for equipping, financing and maintaining city-owned or controlled parks, recreation areas and facilities in and outside the corporate limits of the city in its annual appropriation ordinance.

Section 3

To the extent only that they conflict with this ordinance, the Council repeals any conflicting ordinances or parts of ordinances. The provisions of this ordinance are severable, and invalidity of any part shall not affect the validity or effectiveness of the rest of this ordinance.
