

ORDINANCE NO. 7583

AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING SECTION 10.56.020 OF THE RIVERSIDE MUNICIPAL CODE DESIGNATING THE RESTRICTION OF COMMERCIAL VEHICLES FOR CERTAIN STREETS AND PORTIONS THEREOF TO ESTABLISH 5-TON WEIGHT LIMIT RESTRICTIONS ON COYOTE BUSH ROAD FROM VAN BUREN BOULEVARD TO APTOS LANE AND SECTION 10.56.050 OF THE RIVERSIDE MUNICIPAL CODE TO ESTABLISH AXLE RESTRICTIONS ON VAN BUREN BOULEVARD FROM COYOTE BUSH ROAD TO DAUCHY AVENUE.

The City Council of the City of Riverside does ordain as follows:

<u>Section 1</u>: Section 10.56.020 of the Riverside Municipal Code, is hereby amended to read as follows:

"Section 10.56.020 Commercial vehicles exceeding 10,000 pounds (5 Tons) gross weight prohibited from using certain streets.

When signs are erected giving notice thereof, no person shall operate any commercial vehicle exceeding 10,000 pounds (5 tons) gross weight at any time upon any of the streets or parts of streets listed below, except that such vehicle may be operated thereon for the purpose of delivering or picking up materials or merchandise or the performance of services in connection with and in aid of a property in the block, and then only by entering such street at the intersection nearest the destination of the vehicle and proceeding thereon no farther than the nearest intersection thereafter, and except as provided in Section 10.56.030:

change in the environment nor have a significant impact on the environment. Furthermore, pursuant to Section 15301(c), it is exempt from further review as an operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of an existing public street.

Section 3: The City Clerk shall certify to the adoption of this ordinance and cause publication once in a newspaper of general circulation in accordance with Section 414 of the Charter of the City of Riverside. This ordinance shall become effective on the 30th day after the date of its adoption.
