AN ORDINANCE: TO AMEND TOWN CODE SECTION 10-2 (VOTING PLACES) OF CHAPTER 10 (ELECTIONS) TO RELOCATE THREE VOTING PLACES IN THE TOWN OF LEESBURG, VIRGINIA

WHEREAS, Code of Virginia of 1950 as amended, sections 24.2-308 and 24.2-310 authorize the Town Council to make the necessary changes to the Leesburg Town Code, as captured below; and

WHEREAS, the Town Council desires to relocate the voting places for three (3) precincts within the Town as requested by the Loudoun County Office of Elections (“Office of Elections”):

- A. **Dry Mill Precinct:** The Office of Elections must relocate this voting place from the C.S. Monroe Technology Center (“Monroe Tech”) to Loudoun County High School located at 415 Dry Mill Road, SW., because Monroe Tech will be undergoing renovations;
- B. **Greenway Precinct:** The Office of Elections must relocate this voting place from Leesburg Community Church to J.L. Simpson Middle School located at 490 Evergreen Mill Road, SE, Leesburg, because the Leesburg Community Church has notified the Office of Elections that it no longer wishes to serve as a voting location; and
- C. **Brandon Park Precinct:** The Office of Elections must relocate this voting place from Loudoun County High School to Douglass Community Center located at 405 E. Market Street, Leesburg. Loudoun County High School will be the new voting place for the Dry Mill Precinct and the Douglass Community Center is geographically within the precinct boundaries and closer to the voters within the precinct.

WHEREAS, if enacted, the relocation of the voting places will become effective for the June 2018 Primary Election; and

WHEREAS, Section 24.2-306 of the Code of Virginia of 1950, as amended, requires publication once a week for two successive weeks of intent to change the Town’s voting places and this notification and publication has occurred; and

WHEREAS, a public hearing was held prior to the enactment of this ordinance as required by the Code of Virginia.

THEREFORE, ORDAINED, by the Council of the Town of Leesburg in Virginia as follows:

**SECTION I.** Chapter 10 (Elections) is hereby amended to read as follows:

**Section 10.2 - Voting Places**

The election of town officials and the voting place for such election in the Greenway Precinct Number 1440A shall be at the ~~Leesburg Baptist Church, 835 Lee Avenue, SW~~ **J.L. Simpson Middle School, 490 Evergreen Mill Road, SE**; the election of town officials and the voting place for such election in the Ball's Bluff Precinct Number 1440B shall be at Ball's Bluff Elementary School, 821 Battlefield Parkway, NE; the election of town officials and the voting place for such election in the Evergreen Precinct Number 1440C shall be at Evergreen Mill Elementary School, 491 Evergreen Mill Road, SE; the election of town officials and the voting place for such election in the Tolbert Precinct Number 1440D shall be at John W. Tolbert, Jr. Elementary School, 691 Potomac Station Drive, NE; the election of town officials and the voting place for such election in the West Leesburg Precinct Number 1440E shall be at the Ida Lee Recreation Center, 60 Ida Lee Drive, NW; the election of town officials and the voting place for such election in the East Leesburg Precinct Number 1440F shall be at Frances Hazel Reid Elementary School at 800 North King Street NE; the election of town officials and the voting place for such election in the Dry Mill Precinct Number 1440G shall be at ~~C.S. Monroe Technology Center, 715 Childrens Center Road, SW~~ **Loudoun County High School, 415 Dry Mill Road, SW**; the election of town officials and the voting place for such election in the Smarts


Mill Precinct Number 1440H shall be at Smarts Mill Middle School, 850 North King Street NE; the election of town officials and the voting place for such election in the Cool Spring Precinct Number 1440I shall be at the Cool Springs Elementary School, 501 Tavistock Drive SE; the election of town officials and the voting place for such election in the Brandon Park Precinct Number 1440J shall be at the ~~Loudoun County High School, 415 Dry Mill Road, SW~~ **Douglass Community Center, 405 E. Market Street**; the election of town officials and the voting place for such election in the Heritage Precinct Number 1440K shall be at the Heritage High School, 520 Evergreen Mill Road, SE.

**SECTION II.** All prior ordinances in conflict herewith are hereby repealed.

**SECTION III.** Severability. A determination of invalidity or unconstitutionality by a court of competent jurisdiction of any clause, sentence, paragraph, section or part of this section shall not affect the validity of the remaining parts thereto.

**SECTION IV.** This ordinance shall be effective upon passage.
