**AN ORDINANCE TO AMEND ARTICLE 3, ALCOHOLIC BEVERAGES
OF THE CITY OF ROSWELL CODE OF ORDINANCES TO ADD A NEW
SECTION, ARTICLE 3.7.21, HOME DELIVERY OF ALCOHOL BY
AUTHORIZED PACKAGE GOODS RETAILER**

WHEREAS, Article 3 of the City of Roswell Code of Ordinances provides regulations governing the sale and service of alcoholic beverages in the City; and

WHEREAS, the Mayor and Council of the City of Roswell are charged with the protection of the health, safety and welfare of the citizens of the City; and

WHEREAS, Mayor and Council have determined it is appropriate from time to time to modify such regulations to comport with changing conditions; and

WHEREAS, Mayor and Council desire to amend Article 3 (Alcoholic Beverages) of the City of Roswell Code of Ordinances to allow home delivery of alcohol in accordance with the provisions of Georgia HB 879;

NOW THEREFORE, Mayor and Council ordain as follows:

1. Article 3 is hereby amended to add the following:

Section 3.7.21 Home Delivery of Alcohol By An Authorized Package Goods Retailer

- (a) For all purposes of this section, a “package goods retailer” shall have the same meaning as provided in O.C.G.A. Section 3-3-10.
- (b) Home delivery of alcohol is permitted as set out in state law, O.C.G.A. Section 3-3-10 (Georgia House Bill 879) and by regulations promulgated by the Georgia Department of Revenue, by an authorized package goods retailer as defined by such state law, provided such authorized package goods retailer has obtained the requisite additional license to deliver from the City. Such “License To Deliver” shall be separate from the required underlying alcohol permit and shall require payment of a separate fee for such “License To Deliver.”
- (c) Application for a “License To Deliver” shall be made only by the existing licensee for the business.
- (d) The fee for the “License To Deliver” shall be set by Mayor and Council by resolution.

This Ordinance shall take effect and be in force from and after the day of its adoption, the public welfare demanding it.


