**ORDINANCE NO. 219**

**AN ORDINANCE TO AMEND Chapter 40- ZONING OF THE CITY CODE OF ORDINANCES**

**THE CITY OF CEDAR SPRINGS ORDAINS:**

**Section 1.** Amendment to Modify Chapter 40-Zoning. That the Code of Ordinances of the City of Cedar Springs is amended to;

**Modify** the map entitled "The Zoning Map of Cedar Springs" which according to Sec. 40-132 is part of the zoning ordinance and shall be identified by the signature of the zoning administrator, attested to by the city clerk.

Said map is attached to and considered part of this ordinance and reflects updates to the City's zoning districts made since 2008.

The official zoning map shall be located in the office of the zoning administrator and shall be the final authority as to the current zoning status in the city.

**Section 2. Severability and Repealer.** If any portion of this Ordinance shall be held to be unlawful, the remaining portions shall remain in full force and effect. All ordinances and parts of ordinances in conflict herewith are hereby repealed.

**Section 3. Effective Date.** This ordinance shall take effect upon its publication in The Cedar Springs Post, a newspaper of general circulation in the City of Cedar Springs, consistent with state law and the City Charter.






