15 SET FORTH IN THIS CODE, AN APPLICATION FOR ROOF-MOUNTED ANTENNAL
16 STRUCTURES MORE THAN 12 FEET IN HEIGHT ABOVE THE ROOF SHALL BE
17 APPROVED. A PERMIT APPLICATION FOR A ROOF-MOUNTED ANTENNAL
18 STRUCTURE UNDER THIS SUBSECTION SHALL BE ACCOMPANIED BY
19 DETAILED DRAWINGS OF THE STRUCTURE AND METHOD OF ANCHORAGE.
20 ALL CONNECTIONS TO THE ROOF STRUCTURE SHALL BE PROPERLY FLASHED
21 TO MAINTAIN WATER TIGHTNESS. THE DESIGN AND MATERIALS OF
22 CONSTRUCTION SHALL COMPLY WITH THE REQUIREMENTS OF THIS
23 SUBSECTION (3108.3) FOR CHARACTER, QUALITY, AND MINIMUM
24 DIMENSION.

25 **3108.3.3 DISH ANTENNAS.** A DISH ANTENNA IS AN ANTENNA THAT
26 CONSISTS OF A RADIATION ELEMENT THAT TRANSMITS OR RECEIVES
27 RADIATION SIGNALS GENERATED AS ELECTRICAL, LIGHT, OR SOUND
28 ENERGY. A DISH ANTENNA IS SUPPORTED BY A STRUCTURE WITH OR

PERMITS ARE NOT REQUIRED FOR DISH ANTENNAS THAT ARE 3 FEET OR LESS IN DIAMETER AND THAT ARE ERECTED AND MAINTAINED ON THE ROOF OF A BUILDING.

3108.3.3.2 STRUCTURAL PROVISIONS. DISH ANTENNAS LARGER THAN 3 FEET IN DIAMETER ARE SUBJECT TO THE STRUCTURAL PROVISIONS OF SECTIONS 1608 AND 1609. THE SNOW LOAD PROVISION OF SECTION 1608 SHALL NOT APPLY WHERE THE ANTENNA HAS A HEATER TO MELT FALLING SNOW.

SUBSECTION 3109: SWIMMING POOL ENCLOSURES AND SAFETY DEVICES:

3109.1 GENERAL. SWIMMING POOLS SHALL COMPLY WITH THE REQUIREMENTS OF SECTIONS 3109.2 THROUGH 3109.3 AND OTHER APPLICABLE REQUIREMENTS OF THE CODE.

3109.2 RESIDENTIAL SWIMMING POOLS. RESIDENTIAL SWIMMING POOLS SHALL BE COMPLETELY ENCLOSED BY A BARRIER COMPLYING WITH SECTIONS 3109.2.1 THROUGH 3109.2.3.

EXCEPTION: WHEN APPROVED BY THE BUILDING OFFICIAL, A SWIMMING POOL WITH A POWER SAFETY COVER OR A SPA WITH A SAFETY COVER COMPLYING WITH ASTM F 1346 DOES NOT NEED TO BE COMPLETELY ENCLOSED AS REQUIRED BY THIS SECTION. .

3109.2.1 BARRIER HEIGHT AND CLEARANCES. THE TOP OF THE BARRIER SHALL BE AT LEAST 48 INCHES (1219 MM) ABOVE GRADE MEASURED ON THE SIDE OF THE BARRIER WHICH FACES AWAY FROM THE SWIMMING POOL. THE MAXIMUM VERTICAL CLEARANCE BETWEEN GRADE AND THE BOTTOM OF THE BARRIER SHALL BE 2 INCHES (51MM) MEASURED ON THE SIDE OF THE BARRIER WHICH FACES AWAY FROM THE SWIMMING POOL. WHERE THE

TOP OF THE POOL STRUCTURE IS ABOVE GRADE, SUCH AS AN ABOVE-GROUND POOL, THE BARRIER MAY BE AT GROUND LEVEL, SUCH AS THE POOL STRUCTURE OR MOUNTED ON TOP OF THE POOL STRUCTURE. WHERE THE BARRIER IS MOUNTED ON TOP OF THE POOL STRUCTURE, THE MAXIMUM VERTICAL CLEARANCE BETWEEN THE TOP OF THE POOL STRUCTURE AND THE BOTTOM OF THE BARRIER SHALL BE 4 INCHES (102MM).

3109.2.1.1 OPENINGS. OPENINGS IN THE BARRIER SHALL NOT ALLOW PASSAGE OF A 4-INCH-DIAMETER (102 MM) SPHERE.

3109.2.1.2 SOLID BARRIER SURFACES. SOLID BARRIERS WHICH DO NOT HAVE OPENINGS SHALL NOT CONTAIN INDENTATIONS OR PROTRUSIONS EXCEPT FOR NORMAL CONSTRUCTION TOLERANCES AND TOOLED MASONRY JOINTS.

3109.2.1.3 CLOSELY SPACED HORIZONTAL MEMBERS. WHERE THE BARRIER IS COMPOSED OF HORIZONTAL AND VERTICAL MEMBERS AND THE DISTANCE BETWEEN THE TOPS OF THE HORIZONTAL MEMBERS IS LESS THAN 45 INCHES (1143 MM), THE HORIZONTAL MEMBERS SHALL BE LOCATED ON THE SWIMMING POOL SIDE OF THE FENCE. SPACING BETWEEN VERTICAL MEMBERS SHALL BE NOT GREATER THAN 1¾ INCHES (44 MM) IN WIDTH. WHERE THERE ARE DECORATIVE CUTOUTS WITHIN VERTICAL MEMBERS, SPACING WITHIN THE CUTOUTS SHALL BE NOT GREATER THAN 1¾ INCHES (44 MM) IN WIDTH.

3109.2.1.4 WIDELY SPACED HORIZONTAL MEMBERS. WHERE THE BARRIER IS COMPOSED OF HORIZONTAL AND VERTICAL MEMBERS AND THE DISTANCE BETWEEN THE TOPS OF THE HORIZONTAL MEMBERS IS 45 INCHES (1143 MM) OR MORE, SPACING BETWEEN VERTICAL MEMBERS SHALL BE NOT GREATER THAN 4 INCHES (102 MM). WHERE THERE ARE DECORATIVE CUTOUTS WITHIN VERTICAL MEMBERS, SPACING WITHIN THE CUTOUTS SHALL BE NOT GREATER THAN 1¾ INCHES (44 MM) IN WIDTH.

3109.2.1.5 CHAIN LINK DIMENSION. MESH SIZE FOR CHAIN LINK FENCES SHALL BE NOT GREATER THAN A 2¼ INCH SQUARE (57 MM SQUARE) UNLESS THE FENCE IS PROVIDED WITH SLATS FASTENED AT THE TOP OR THE

1 BOTTOM THAT REDUCE THE OPENING TO NOT MORE THAN 1¾ INCHES (44
2 MM).

3 **3109.2.1.6 DIAGONAL MEMBERS.** WHERE THE BARRIER IS COMPOSED OF

18 GATE AND BARRIER SHALL BE WITHOUT OPENING LARGER THAN ½ INCH (13

20 **3109.2.1.8 DWELLING WALL AS A BARRIER.** WHERE A WALL OF A

2. THE POOL SHALL BE EQUIPPED WITH A POWERED SAFETY COVER IN COMPLIANCE WITH ASTM F 1346; OR

3. OTHER MEANS OF PROTECTION, SUCH AS SELF-CLOSING DOORS WITH SELF-LATCHING DEVICES, WHICH ARE APPROVED, SHALL BE ACCEPTABLE SO LONG AS THE DEGREE OF PROTECTION AFFORDED IS NOT LESS THAN THE PROTECTION AFFORDED BY ITEM 1 OR 2 DESCRIBED ABOVE.

3109.2.1.9 POOL STRUCTURES AS BARRIERS. WHERE AN ABOVE-GROUND POOL STRUCTURE IS USED AS A BARRIER OR WHERE THE BARRIER IS MOUNTED ON TOP OF THE POOL STRUCTURE, AND THE MEANS OF ACCESS IS A LADDER OR STEPS, THEN THE LADDER OR STEPS SHALL BE CAPABLE OF BEING SECURED, LOCKED OR REMOVED TO PREVENT ACCESS, OR THE LADDER OR STEPS SHALL BE SURROUNDED BY A BARRIER WHICH MEETS THE REQUIREMENT OF SECTION 3109.2.1 THROUGH 3109.2.1.8. WHERE THE LADDER OR STEPS ARE SECURED, LOCKED OR REMOVED, ANY OPENING CREATED SHALL NOT ALLOW THE PASSAGE OF A 4 – INCH DIAMETER (102 MM) SPHERE.

3109.2.2 INDOOR SWIMMING POOL. WALLS SURROUNDING AN INDOOR SWIMMING POOL SHALL NOT BE REQUIRED TO COMPLY WITH SECTION 3109.2.1.8.

3109.2.3 PROHIBITED LOCATIONS. BARRIERS SHALL BE LOCATED TO PROHIBIT PERMANENT STRUCTURES, EQUIPMENT OR SIMILAR OBJECTS FROM BEING USED TO CLIMB THE BARRIERS.

3109.3 ENTRAPMENT AVOIDANCE. SUCTION OUTLETS SHALL BE DESIGNED AND INSTALLED IN ACCORDANCE WITH ANSI/APSP-7.

3109.4. ALTERNATIVE DEVICES. NATURAL BARRIERS, POOL COVERS, OR OTHER PROTECTIVE DEVICES APPROVED BY THE BUILDING OFFICIAL SHALL BE AN ACCEPTABLE ENCLOSURE IF THE DEGREE OF PROTECTION AFFORDED BY THE SUBSTITUTED DEVICE OR STRUCTURE IS GREATER THAN THE

7 **3114.1 GENERAL.** FOR THE PURPOSE OF THIS SECTION, THE FLOODPLAIN IS
8 DELINEATED IN TITLE 16, SUBTITLE 7 OF THE HOWARD COUNTY CODE.

9 **3114.2 WITHIN DESIGNATED FLOODPLAIN.**

10 THE CONSTRUCTION, RECONSTRUCTION, MODIFICATION, ALTERATION,
11 REPAIR, OR IMPROVEMENT OF BUILDINGS, MANUFACTURED HOMES, OR
12 OTHER STRUCTURES LOCATED WITHIN A DESIGNATED FLOODPLAIN SHALL

12 **3114.4.1 RESIDENTIAL.** IN NEW CONSTRUCTION OF RESIDENTIAL

29 **3114.5.2 NONRESIDENTIAL.** THE LOWEST FLOOR, INCLUDING A

CAPABILITIES SHALL BE THOSE DESCRIBED IN FLOODPROOFING

U.S. ARMY, WASHINGTON, D.C., DECEMBER 1995, OR SUBSEQUENT

3114.6 VERIFICATION. FOR THE PURPOSE OF VERIFYING COMPLIANCE

2 MARYLAND, CERTIFYING THAT THE AS-BUILT LOWEST FLOOR OF

17 **3114.7 DEFINITIONS.** NOTWITHSTANDING CHAPTER 2 OF THE

26 **BASEMENT.** AN ENCLOSED AREA THAT IS BELOW GRADE ON ALL SIDES.

27 **FLOODPLAIN.** SHALL BE AS DELINEATED IN TITLE 16, SUBTITLE 7 OF THE
28 HOWARD COUNTY CODE.

29 **FLOODPROOFING.** ANY COMBINATION OF ADDITIONS, CHANGES, OR
30 ADJUSTMENTS TO A STRUCTURE WHICH REDUCE OR ELIMINATE FLOOD
31 DAMAGE TO REAL ESTATE OR IMPROVED REAL PROPERTY, WATER OR

1 SANITARY FACILITIES, OR STRUCTURES AND THEIR CONTENTS , SUCH THAT
2 THE BUILDINGS OR STRUCTURES ARE WATERTIGHT WITH WALLS
3 SUBSTANTIALLY IMPERMEABLE TO THE PASSAGE OF WATER AND WITH
4 STRUCTURAL COMPONENTS HAVING THE CAPABILITY OF RESISTING
5 HYDROSTATIC AND HYDRODYNAMIC LOADS AND EFFECTS OF BUOYANCY.

6 **HISTORIC STRUCTURE.** A BUILDING LISTED ON THE NATIONAL REGISTER
7 OF HISTORIC PLACES, A STATE INVENTORY OF HISTORIC PLACES, OR AN
8 INVENTORY OF HISTORIC STRUCTURES ADOPTED BY RESOLUTION OF THE
9 COUNTY COUNCIL. A HISTORIC STRUCTURE ALSO INCLUDES A STRUCTURE
10 THAT IS CERTIFIED OR PRELIMINARILY DETERMINED BY THE UNITED
11 STATES SECRETARY OF THE INTERIOR AS CONTRIBUTING TO THE
12 HISTORICAL SIGNIFICANCE OF A REGISTERED HISTORIC DISTRICT OR A
13 DISTRICT PRELIMINARILY DETERMINED BY THE SECRETARY TO QUALIFY AS
14 A REGISTERED HISTORIC DISTRICT.

15 **LOWEST FLOOR.** THE LOWEST FLOOR OR THE LOWEST ENCLOSED AREA,
16 INCLUDING A BASEMENT. LOWEST FLOOR DOES NOT INCLUDE AN
17 UNFINISHED OR FLOOD RESISTANT ENCLOSURE USED SOLELY FOR PARKING
18 VEHICLES, BUILDING ACCESS, OR STORAGE IN AN AREA OTHER THAN A
19 BASEMENT AREA. THE ENCLOSURE SHALL NOT BE BUILT SO AS TO RENDER
20 THE STRUCTURE IN VIOLATION OF THE APPLICABLE NON-ELEVATION
21 DESIGN REQUIREMENTS OF SUBSECTIONS 3114.4 AND 3114.6 OF THIS

23 **MANUFACTURED HOME.** A MANUFACTURED HOME SHALL HAVE THE

26 **NEW CONSTRUCTION.** STRUCTURES, INCLUDING ADDITIONS AND
27 IMPROVEMENTS, AND THE PLACEMENT OF MANUFACTURED HOMES, FOR
28 WHICH THE START OF CONSTRUCTION COMMENCED ON OR AFTER
29 3/15/1977, THE INITIAL EFFECTIVE DATE OF THE HOWARD COUNTY FLOOD
30 INSURANCE RATE MAP, INCLUDING ANY SUBSEQUENT IMPROVEMENTS,
31 ALTERATIONS, MODIFICATIONS, AND ADDITIONS TO SUCH STRUCTURES.

1 THE REPAIR OR REPLACEMENT OF A MANUFACTURED HOME BECAUSE OF
2 SUBSTANTIAL DAMAGE IS CONSIDERED TO BE NEW CONSTRUCTION AND IS
3 PROHIBITED IN ACCORDANCE WITH SECTION 3114.2.1 OF THIS CODE.

4 **STRUCTURE.** FOR PURPOSES OF THIS SUBSECTION 3114 TO THIS CODE,
5 SHALL HAVE THE MEANING SET FORTH IN TITLE 16, SUBTITLE 7 OF THE
6 HOWARD COUNTY CODE.

7 **SUBSTANTIAL DAMAGE.** DAMAGE OF ANY ORIGIN SUSTAINED BY A
8 STRUCTURE WHERE THE COST OF RETURNING THE STRUCTURE TO ITS
9 CONDITION PRIOR TO DAMAGE WOULD EQUAL OR EXCEED 50% OF THE
10 STRUCTURE'S FAIR MARKET VALUE BEFORE THE DAMAGE OCCURRED.

11 **SUBSTANTIAL IMPROVEMENT.** THE REPAIR, RECONSTRUCTION, OR
12 IMPROVEMENT OF A BUILDING OR STRUCTURE, THE COST OF WHICH IS
13 EQUAL TO OR GREATER THAN 50% OF THE FAIR MARKET VALUE OF THE
14 BUILDING OR STRUCTURE PRIOR TO DAMAGE, IMPROVEMENT, OR REPAIR.
15 FOR THE PURPOSE OF THIS DEFINITION, "SUBSTANTIAL IMPROVEMENT"
16 OCCURS WHEN THE FIRST ALTERATION OF A WALL, CEILING, FLOOR, OR
17 OTHER STRUCTURAL PART OF THE BUILDING BEGINS, WHETHER OR NOT
18 THAT ALTERATION AFFECTS THE EXTERNAL DIMENSIONS OF THE BUILDING
19 OR STRUCTURE. THE TERM DOES NOT INCLUDE ANY PROJECT FOR
20 IMPROVING A BUILDING OR STRUCTURE TO COMPLY WITH EXISTING STATE

26 **VARIANCE.** THE GRANT OF RELIEF FROM A TERM OF THIS SUBTITLE.

27 **3114.8 VARIANCES AND WAIVERS.** EXCEPT AS PROVIDED IN SECTION
28 3114.4 OF THIS CODE, A VARIANCE OR WAIVER OF THIS SECTION IS NOT
29 ALLOWED. THE BUILDING OFFICIAL SHALL CONSIDER A VARIANCE IN
30 ACCORDANCE WITH THE PROVISIONS OF SECTION 16.711 OF THE HOWARD
31 COUNTY CODE.

3114.9 OTHER AGENCIES. A PERMIT ISSUED BY THE BUILDING OFFICIAL UNDER THIS SUBTITLE IS NOT VALID UNTIL ALL NECESSARY PERMITS FOR THE DEVELOPMENT ARE OBTAINED. RECEIPT OF FEDERAL OR STATE PERMITS DO NOT EXEMPT A DEVELOPMENT FROM THE PROVISIONS OF THIS SUBTITLE.

(78) *SUBSECTION 3306.10 ACCESSIBILITY DURING CONSTRUCTION OPERATIONS.*

ADD NEW SUBSECTION 3306.10 AFTER SUBSECTION 3306.9 AS FOLLOWS:

3306.10 ACCESSIBILITY DURING CONSTRUCTION OPERATIONS. PRIOR TO AND DURING CONSTRUCTION, THE CONTRACTOR SHALL PROVIDE AND MAINTAIN AT ALL TIMES A MINIMUM 12-FOOT WIDE VEHICULAR ACCESS ROADWAY THAT WILL ALLOW THE UNIMPEDED MOVEMENT OF FIRE OR EMERGENCY RESCUE VEHICLES FROM AN IMPROVED STREET TO WITHIN 200 FEET OF THE MOST REMOTE BUILDING UNDER CONSTRUCTION ON THE SITE. THE VEHICULAR ACCESS ROADWAY SURFACE SHALL BE CRUSHER RUN, STONE BASE, BLACKTOP, OR OTHER SUITABLE COMPACTED SURFACE MATERIAL APPROVED BY THE BUILDING OFFICIAL.

SECTION 3315 CONSTRUCTION SITE GRADING.

3315.1 LOT IMPROVEMENTS. LOT IMPROVEMENTS SHALL PROVIDE:

- (I) SUITABLE ACCESS FROM AN ABUTTING STREET TO DWELLINGS AND ACCESSORY BUILDINGS SUBJECT TO A PERMIT;
- (II) GRADING WHICH WILL DIVERT WATER AWAY FROM BUILDINGS AND PREVENT STANDING WATER AND SOIL SATURATION DETRIMENTAL TO STRUCTURES OR LOT USE;
