

ORDINANCE 2022 – 64

AN ORDINANCE OF THE CITY OF MT. JULIET TO AMEND THE MT. JULIET CITY CODE CHAPTER 28 -TRAFFIC AND VEHICLES, ARTICLE VII – PARKING, SECT. 28-193 REGULATIONS (PARKING VIOLATIONS)

Whereas, the Board of Commissioners of the City of Mt. Juliet desire to amend Chapter 28 – Traffic & Vehicles, Article VII – Parking, Sect. 28-193 Regulations to permit a the clerk in the police department to dismiss a parking citation if not cited within the past 12-month period, and;

Whereas, Section 28-193 Regulations is amended to add the following: “Upon presentation to a clerk, the citation may be dismissed with no monetary fine or costs if it is determined the offender does not have previous violations in the 12-month period prior to the date of offense. This action may be performed by any clerk of the police department”.

Now, therefore, be it ORDAINED by the City of Mt Juliet Board of Commissioners the City of Mt. Juliet City Code Chapter 4 Alcoholic Beverages, is amended as follows:

Sec. 28-193 Regulations to insert the following: (See attached Code section)

“Upon presentation to a clerk, the citation may be dismissed with no monetary fine or costs if it is determined the offender does not have previous violations in the 12-month period prior to the date of offense. This action may be performed by any clerk of the police department.”

BE IT FURTHER ORDAINED

Section 1. In case of conflict between this ordinance or any part hereof, and the whole or part of any existing ordinance of the City, the conflicting ordinance is repealed to the extent of the conflict but no further.

Section 2. If any section, clause, provision or portion of this ordinance is held to be invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, provision or portion of this ordinance.

Section 3. That this ordinance shall take effect at the earliest date allowed by law, the public welfare requiring it.

Sec. 28-193. Regulations.

Except as otherwise provided in this section, no person shall leave any vehicle or trailer or other conveyance parked on any public street or alley between the hours of 1:00 a.m. and 5:00 a.m. Notwithstanding the foregoing, temporary permits for overnight parking may be issued by the chief of police, upon application, for extraordinary and temporary circumstances. Further, the city traffic commission may exempt individual streets or alleys, or sections of streets or alleys, from the prohibition against parking between the hours of 1:00 a.m. and 5:00 a.m. when such a request is made by the affected homeowners or the applicable homeowners association and upon a showing that such an exemption will not unreasonably impede safe traffic flow or otherwise create an unsafe condition. Vehicles or trailers found parked on any nonexempt public street or alley between 1:00 a.m. and 5:00 a.m. without a temporary permit will be ticketed. Upon presentation to a clerk, the citation may be dismissed with no monetary fine or costs if it is determined the offender does not have previous violations in the 12-month period prior to the date of offense. This action may be performed by any clerk of the police department. Vehicles that are parked in such a way as to cause an obstruction or hazard to normal traffic flow will be towed, with all towing and storage costs charged to the owner.
